horses the said Edwards his heirs and assigns forever.
- Item 2 I give to my grandson Benjamin Randolph
the first, Colored Negroes, Mike, Moses, Ned, and Mary
with her future increase to be delivered to him when
he arrives at the age of twenty one to him and his
heirs and assigns forever.
- Item 3 I give and bequeath unto my grand son Gerard
Lawrence McRee, one negro man named Tom
with his present and future increase to be deli-
vered to him at the age of twenty one, nevertheless
less if my grand son Lawrence McRee should die
before he arrives at the age of twenty one, the said
Negro Woman and her present and future increase shall
return and be divided among my three children -
Edward, Dick, and Nancy.
- Item 4 I give and bequeath unto my grandson Benjamin
Randolph White, one negro girl named Nancy, the
daughter of Mary, nevertheless if my grand son
Benjamin Randolph White should die before
he arrives at the age of twenty one, the said girl
Nancy, he gives to my daughter Nancy.
- Item 5 I give to my son in law James McRee his
slaves Sterling.
- Item 6 I give to my daughter Dick the following negroes
Joe Cook, Laber, Dick her present and future increase
Mary with her future increase, Jean, Dick's present
and future increase to her the said Dick, her heirs
and assigns forever.
- Item 7 I give to my daughter Nancy the following negroes
Charl, Ben, and Mary, with her present and future
increase, Nancy excepted, also Ella with her present
and future increase to her the said Nancy her
heirs and assigns forever.
- I do hereby constitute and appoint Edward
Randolph Malcom McRee and George
Kingsley, my true and lawful Executors of this
my last Will and Testament hereby revoking and
disannulling all other former Wills by me made
