THIRD: (a) I give and devise to my beloved daughter Clarida (Galloway) Sparrow \$112.50; (b) to my beloved daughter Celia (Galloway) Griffin \$112.50 (c) and to my beloved son Abram Galloway, Jr. \$112.50 and to my beloved daughter Mamie (Galloway) Lee \$112.50; the aforesaid Clarida Galloway Sparrow, Celia Galloway Griffin and Abram Galloway Jr. and Mamie Galloway Lee being the heirs at law of Celia Galloway my present wife.

FOURTH: To my beloved wife Celia Galloway I give all the rents and profits from all my real estate during her natural life for her support. After her death to be delivered in equal proportions to and among all my heirs at law both by my first and second wife.

FIFTH: To my beloved son Abram Galloway Jr. I give and devise One DeSmet Truck.

SIXTH: To William Wortham a fatherless boy now living in my house I give and devise my mule and wagon.

SEVENTH: I hereby constitute and appoint my friend Oscar Galloway my lawful executor to all intents and purposes, to execute this my last will and testament, according to the true intent and meaning of the same, and every part and clause thereof, hereby revoking and declaring utterly void all other wills and testaments by me heretofore made.
