I, Albert McKoy, of North West, in said county and state, being of sound mind, good health and disposing mind, dealring to leave a Last Will and Testament, do hereby make, publish and declare this to be my Last Will and Testament, and I do name, nominate and make my true and trusted friend, James Brown my lawful Executor of this my Last Will and Testament, revoking all other wills and testament, or Codiciles made by me, and my said Executor may serve without Bond.

FIRST: I give my soul to God who gave it, and my body th the dust.

SECOND: I desire that my body be given a decent burial, and a suitable stone to be erected marking my last resting place, same to be paid for out of my Estate, together with all my burial expenses.

THIRD: I desire that all my just debts be paid -- should I leave any due at the time of my death:

POUNTH: I give, bequeath, grant and convey unto my beloved wife, NELLA Mea Koy, two tracts of land, on which we now reside, on consisting of two (20 acres, bought of L. J. McKoy by Deed dated April 14th, 1927, and one other tract containing 2 and 1/4 acres bought of L. J. McKoy by deed dated May 17th; A. D. 1926 described as Lot No. 2 of the McKoy survey: TO HAVE AND TO WOLD IN FEE SIMPLE: together wath all my Household effects, and personal property, but CONDITIONED, NEVERTHELESS, that this is given provided the said NELLA McKOY, shall remain with me, and do her part by me, untill my death:

I the said Albert McKoy, do declare this to be my last will and testament, made, Executed and delivered, at North West, this the 8th day of February, A. D. 1935.
