I, Anne Goodman, of Brunswick County, in the State of North Carolina, widow, being in health, but of body and mind, but calling to mind the mortality of my body, and that it is appointed unto all men to die, do make and ordain this my last will and testament, and as to what worldly estate wherewith it has pleased God to bless me with in this life, I give, devise and dispose in the following manner and form. Item, I give and bequeath to my daughter Lydia one of my best riding Beast, to her and her heirs forever. Item, I give to my daughter Sarah Goodman, one negro man named Scipio, and one negro woman named Phoebe and increase to her and to the heirs of her body forever, and in case there be no heirs of her body, and when no heirs of her body, I give the said negroes and increase to be equally divided among all of my surviving children to them and their heirs forever. Item, as I give all the remainder of my estate to be equally divided amongst all my children, that is to say, Mary Kingate, Robert Potter, Amelia Ross, Lydia Cain, Saml. Potter, Sarah Goodman, to be theirs forever. Lastly, I make, ordain, constitute and appoint Samuel Potter, Nath. Wragg, Executors of this my last Will & Testament, ratifying and confirming the same and now here to be my last will and Testament. In witness whereof I have hereunto set my hand and seal this Eighteenth day of April, 1800. The words Sam'l. Potter in the 15th line, interlined before signed

In the name of God, Amen! I, Elisha Sellers, of Brunswick County, in the State of North Carolina, being weak of body, but of perfect mind and sound memory, calling to mind the mortality of my flesh, and that it is appointed unto all men to die, do make and ordain this my last Will and Testament in form & manner following: First and principally I recommend my soul to God, who gave it, trusting in the merits of Christ for a Glorious Resurrection, and my body to be buried after a Christian manner at the discretion of my executors hereinafter named. nothing doubting but I shall receive the same again through the mighty power of God, and touching such worldly good wherewithal it hath pleased God to bless me with, I give, devise and bequeath in manner & form following: - First, I give unto my beloved wife, Mary Sellers, the use of the plantation whereon I now live during her life or widowhood, and after her death or marriage to revolve to my son John Bryant Sellers. Secondly, I give unto my daughters, Sarah McClelland & Mary Singletary, and my sons William Sellers, Thomas Sellers, Matthew Sellers, and Hallett Sellers, and also my daughter Anna Peoples Meeks One shilling to each of them. Thirdly, I give unto my wife Mary Sellers her equal part of the remaining part of my property not hereinbefore given. I mean one hundred. Fourthly, It is my will and desire that the remaining part of my property may be equally divided between all the children which I have had or may hereafter have by my said wife Mary, share & share alike. Fifthly I give unto my Grandsons Elisha Sellers and William Sellers one half each to each of them. Lastly, I nominate, constitute and appoint my beloved wife, Mary Sellers, Executrix, my dutiful son Thomas Sellers and my friend John Conyers as Executors to this my last will and testament. First, revoking all former wills by me heretofore made; and ratifying and confirming this to be my last Will and Testament. In witness whereof I have hereunto set my hand & affixed my seal this Sixteenth day of November One thousand eight hundred and nine.
