

Will of Arthur Smith.

In the name of God, I Arthur Smith, of the borough Swarthmore, in the county of Delaware and state of Pennsylvania of the age of thirty years and upward, and being of sound, disposing mind and memory, do hereby make public and declare this to be my last will and testament,

that is to say, first. I direct that all my just debts and funeral expenses be first paid and fully satisfied. Second. I give and devise the real property now occupied by me as my present residence, and all residue of every name and nature, and wherever situated, unto my beloved wife, Rosanna Smith, absolutely and forever. I appoint her my executrix of this my last will and testament, hereby revoking all former wills by me made.
