

State of North Carolina Brunswick County,

I J. J. Bennett of the aforesaid County and state, being of sound mind but considering the uncertainty of my earthly existence do make and declare this my last will and testament.

First: I give to P. M. Blanton and wife Minnie O. Blanton the tract of land on which I now live.

Beginning at a pine near East 54 chains and 78 links to a small pine thence north 27 chains and 39 links to another small pine thence East 54 chains and 78 links to a pine thence South to the beginning containing one hundred and twenty five acres more or less, I J. J. Bennett hereby except ten acres of the above described premises formerly sold to T. D. Long.

Second: I give to Sarah D. Long a certain tract of land on the south side of Little Cow Cow swamp and on the east side of big Cow Cow swamp known and described as follows. Beginning at a lightwood stake on pine log branch known as the lot Benton corner runs West 150 poles to Alfred Bennett corner thence north 98 poles with said Alfred Bennett line to J. M. Todd's corner thence with said Todd's line East 200 poles to J. M. Todd's corner thence about north to W. H. Stone's line thence with Stone's line to the Benjamin Bennett corner thence with said Bennett line to or near the head of pine log branch thence with the meanders of said branch to the beginning containing three hundred and eighty nine acres more or less. I hereby except sixty five acres more or less formerly sold to T. D. Long & C. Long also a small tract formerly conveyed to Jesse Bennett from the above described premises also two tracts of land in big Cow Cow swamp near the mouth of Little Cow Cow swamp containing twenty acres more or less.

Third: I give to P. M. Blanton one gray horse name named Ed. for team of cattle, my entire stock of hogs one farm cart one buggy and harness all my farming utensils and all other personal property.

It is expressly understood by all the parties to this will that I J. J. Bennett do hereby require and bind the said P. M. Blanton Minnie O. Blanton and Sarah D. Long to provide & take care of my aged mother Susan H. Bennett & Emma V. Bennett my afflicted aunts & see that they are cared for in the best possible way during their natural life

and it is agreed that if the said parties P. M. Blanton, Minnie O. Blanton & Sarah D. Long should fail to comply with this requirement then this will & every part thereof will be null & void otherwise in full force to all intents & purposes.

Third: I hereby constitute & appoint my trusty friend W. H. Stone my lawful executor to all intents & purposes to execute this my last will and testament according to the true intent & meaning of the same & every part & clause thereof hereby creating & declaring void all other wills & testaments by me heretofore made.
