own disposal to do with as she shall think fit. Also I do give and  
bequeath unto my said wife, Mary, a life estate in land which is here  
mentioned, viz.: all that tract of land lying on Bacon Sound, including  
Beach, Marsh and Upland adjoining and out to Scandberg Creek,  
all my land upon Bryan Creek, and adjoining theron, and the  
Mill and plantation with all belonging to said land which I do  
and bequeath to my loving nephew Solomon Hewitt, son of Ruth, but  
all my other lands, with the life estate in lands left to my loving wife  
after her death to go to him the said Solomon Hewitt with my two  
lot to be his forever. Also I do give and bequeath to my brother David  
our bushels of corn to be paid him yearly by my wife, as long as he shall
