A paper writing purporting to be the Last Will & Testament of John Mercer, deceased, is exhibited for probate in open Court by Hon. H. Mercer and J. G. Drew, the Executors therein named and execution thereof by the said John Mercer is proved by the oaths & examination of Henry Addix the subscribing witness thereto. It is therefore concurred by the Court that the said paper with all every part thereof is the last Will and Testament of the said John Mercer and the same is ordered to be recorded and filed. Therefore the said Hon. H. Mercer & J. G. Drew, Executors as aforesaid are duly qualified as such by taking the oath required by law. Said Will is in the following words and figures, to wit:

In the name of God, Amen!

I, John Mercer, of the County of Brunswick and State of North Carolina, being of sound mind and memory, and considering the uncertainty of this frail & transitory life, do therefore make, ordain, publish and declare this to be my last Will and Testament, that is to say - first, after all my lawful debts are paid and discharged the residue of my estate, real and personal, I give, bequeath & devise of as follows, to wit: - To my beloved wife, Jane, and my lawful heirs by her, the homestead tract of land, containing One thousand acres, lying on the east side of Lockwood fork, R. in the County of Brunswick and State of North Carolina, together with all and singular the appurtenances thereto belonging, remainder and residue of all my personal estate to be divided among my lawful heirs at a time discretionary with the Executors of this my last Will and Testament. All my lands I desire to be sold at public or private sale, the proceeds of which to be applied to the payment of my lawful debts until such debts are paid, and should there be a balance remaining in the hands of said Executors that such balance be applied to the education of my children as my Executors may deem proper. Said lands all situated in the County of Brunswick and State of North Carolina, to wit: - One tract known as the Mill tract lying on Epps Creek, the Belfry Saw & Grist Mill now standing, containing fifteen hundred acres; One other tract on Sandy branch containing five hundred acres, about fifty acres excepted, which fifty acres I specifically bargained to sell, justly; One other tract of upland land, lying in the fork of Middle & River branches, containing about seventy-five acres; One other tract of land on Darnell's Branch lying on the East side, containing one hundred & forty acres; Also one water-lot lot in the Town of Smithfield, North Carolina. I further desire that all my other property remain above to my wife and other debts & accounts to be settled.

as may be deemed best by my Executors to this my last Will and Testament. I also desire that the present business operations now being carried on may be continued so long as in their judgment may be deemed best. I also give and bequeath to my esteemed friend, Henry Addix, Four hundred dollars in money for his devotion and strict attention to my business heretofore, and request him to assist in the adjustment & settlement of notes and accounts due me. Likewise I name, constitute and appoint my brother, Hon. Mercer, Thos. G. Drew and John D. Taylor to be executors of this my last Will and Testament, hereby revoking all former wills by me made. In witness whereof I have hereunto subscribed my name & affixed my seal the twenty-fifth day of July in the year of our Lord One thousand, eight hundred and sixty one.

Rufus D. Hewitt comes into open Court and brings the Last Will & Testament of Isaac Hewitt, deceased. Said Will is then duly proved in Open Court by the oath of George Newell, one of the subscribing witnesses and ordered to be recorded. Said Hewitt named as Executor to said Will is then qualified by taking the oath prescribed by Statute.

Said Will is in the following words & figures, to wit:

I, Isaac Hewitt of the County of Brunswick, and State of North Carolina, being of sound mind & memory but considering the uncertainty of my earthly existence, do make & declare this my Last Will and Testament in manner and form following - that is to say -

I direct my Executors shall provide for my body a decent General suitable to the wishes of my relation & friends & my all funeral expenses together with my just & right bequeath and to whomsoever owing any of the money that may first come into my hands as a fund and to be used by my executors.
