(1) I give and bequeath unto my son James Laurence Sprunt, my solitaire diamond engagement ring, and my jewelled bracelet which was my wedding gift from my husband.

(2) I give and bequeath to my daughter-in-law Anoret Cameron Sprunt, my string of pearls, and my pearl and diamond ear-rings, and my diamond crown pin.

(3) I give and bequeath to my niece and namesake Luola Murchison Hurkamp, my large single stone diamond ring to be presented to her on her 15th birthday by her mother or guardian.

(4) I give and bequeath to my nephew Charles H. Hurkamp Jr. my princess ring, with pearl and two diamonds surrounded with small diamonds set therein.

(5) I give and bequeath to my sister Jessie M. Carter my ring set with two pear shaped and two round diamonds.

(6) I give and bequeath to Florence H. Kidder daughter of Mrs. George W. Kidder of Wilmington North Carolina, my diamond chain.

(7) I give and bequeath to my son James Laurence Sprunt, my cousin John De Murchison, George E. Kidder, and to the survivors and survivor of them, as joint tenants and not as tenants in common, one hundred and fifty (150) shares of the capital stock of The Murchison National Bank, of Wilmington, North Carolina, and one hundred and fifty (150) shares of the Atlantic Coast Line Railroad Company standing upon the books of said corporations in my name; in Trust, nevertheless for the following purpose only: To hold
