M. Thompson's on the South, together all of my household and kitchen furniture now possessed by me during the term of her natural life and after her death to be divided equally among my children. And I do further declare that it is my will for my beloved wife Sarah Elizabeth Price to have full control of the above stated house and lot as long as she shall live unmolested by any person or persons.

In witness whereof I have hereunto subscribed my name and affixed my seal this 22nd day of May in the year of our Lord one thousand eight hundred and seventy seven.

Since the within will and Codicil was written in the year one thousand eight hundred May 22. and seventy seven which I bequeath my house kitchen together with household and kitchen furniture and lot No. 2 as aforesaid then of town the Smithville now called Southport in Rutherford County North Carolina, to my beloved wife Elizabeth Price after my demise to have full charge of the same during her life time then to my children which time I have been unfortunate and lost all I had to make a living and since then my daughter Sarah Florence Price has to keep school and otherwise employed has had to furnish means to repair home and fence and all so support her mother and myself and now think it proper and just to give to my daughter Sarah Florence Price after her mother demise if she her mother dies first, the house kitchen and household and kitchen furniture consisting of bedding hearstons Chairs Carpets Crochery ware and other useful articles with the clear understanding clearly my meaning that my daughter Mary Elizabeth shall have a life time right live in the house as a home during her life time with right but shall not have the right till any part of the same and if Florence shall live the longest the house lot and kitchen and furniture shall all be long to Sarah Florence Price and I now wish it clearly understood that Mary Elizabeth Price shall work and do all she can to help support and if they both agree to rent out the house they shall divide the rent equally between them after all expenses is paid, all the above written Codicil I have done being in my right mind and memory and affix my name this 26th of December in the year of our Lord eight hundred and eighty eight.

Since the within Will and Codicil was written in the year one thousand eight hundred (1879) seventy nine in which I bequeathed my house kitchen together with house hold and kitchen furniture and Lot No 2 as expressed in Plan of Town of Smithville, now called Smithville in Brunswick County, North Carolina, to my beloved wife Elizabeth Price after my demise to have full charge of the same during her life time and then to my children. to Sarah Florence Price, and I now wish it clearly understood that Mary Elizabeth Price shall work and do all she can to help support and if they both agree to rent out the House they shall divide the rent equally between them, after all expenses are paid;
