I, Lewis Wilson of the Village of Supply, in the county of Brunswick and State of North Carolina, being of sound mind and memory and discretion do make, publish and declare this instrument as my last will and Testament, hereby revoking and making null and void all wills heretofore by me made.

ITEM 1. I give, devise and bequeath unto my beloved sister Siddia A. Williams her heirs and assigns forever, my estate consisting of one hundred and forty eight (148) acres of land, situate and lying in the County aforesaid, reserving unto myself, however, the right to transfer seall and convey in fee simple to any party or parties at any time during my natural life.

ITEM 2. Give, devise and bequeath unto my beloved sister Siddia A. Williams her heirs and assigns aforesaid, all of my property real, personal and mixed of whatever nature and kind wheresoever the same may be found at my death.

ITEM 3. My Executor hereinafter named shall give my body a decent burial suitable to my situation in life, and pay all funeral expenses, together with my just debts out of the first moneys which may be derived from my estate.

ITEM 4. In case of the death of my beloved sister Siddia A. Williams before my death or demise, I give and devise and bequeath unto her heirs and assigns forever, all of my property mentioned herein, in items one (1) and two (2) of this instrument, subject however to the right reserved unto myself in item 1.

ITEM 5. I hereby appoint my sister Siddia A. Williams, my executrix of this my last will and testament and in case of her demise or decease before my death I hereby appoint James T. Williams as my executor of this will, (who is my nephew.)
