Firstly I hereby revoke and cancel all former
Wills and Codicils,

Secondly I give and bequeath to my beloved
husband Ogden Ellery Edwards the whole
of the property, real and personal of which
I may die possessed in Trust for himself
and our children,

Thirdly The condition of the above Trust
is that the income arising from my
property shall be used for the support
of my said husband and for the sup-
port and education (as he may direct)
of our children so long as my said
husband may live and after his death
the sum of five thousand dollars in
United States gold coin shall be given
my son Ogden Ellery Edwards the Young-
er and the remainder of my property shall
be equally divided among my four children
Chatherine Shepherd Edwards Helen Ed-
wards, Robert Sedgwick Edwards and
Ogden Ellery Edwards the Younger, my
reason for giving five thousand dollars
as above to my son Ogden Ellery Edwards
the Younger is that his sister and brother
already have property of their own,

Fourthly I appoint my said husband Execu-
tor of this Will with power of substitution
and I hereto set my signature and
seal this twenty ninth day of November
in the year of our Lord One thousand
eight hundred and seventy five,
