III I give the one half of my personal estate remaining after the payment of my debts and funeral charges, to my said daughter Mary Catharine, and the other half to my sister, Nancy Wilson, if she be living at my death, but if she be then dead, then I give the said half to my said daughter Mary Catharine

I do hereby appoint my said daughter Mary Catharine sole executrix of this Will hereby revoking all other wills by me heretofore made. In witness whereof, I, the said Sarah Ann Calloway, have hereunto set my hand and seal this seventeenth day of January 1884
