

The Last Will and Testament of Zachariah Candler Deceased

In the name of God amen

I, Zachariah Candler Sen: of Beaufort County and State of North Carolina, Being Sick and Lame but of Sound Mind and calling to mind the Uncertainty of Life do make and constitute and ordain this my Last Will Will and Testament after my death

1st In the first place desire that all of my Just debts be paid Out of my Estate. Say my Lands &c.

2^d Secondly I Lend to my wife Polly Candler during his natural life Time or Widdowhood the houses and Plantation where on I now live Including the 4th Black place and the Mouth of the Truck branch to Jo contain one thousand acres on both Sides of French broad River Laid out to the best advantage

3^d Thirdly It is my will and desire that my wife Polly shall have all my Stock of all kinds and all the household and kitchen furniture and all working tools that is to say horses cattle Sheep and hogs till Lifetime or Widdowhood

4th Fourthly it is my will and desire that all my Son, Thomas Jefferson Candler, ~~son~~ Children that is to say Charles Newton Byron Candler Zachariah Mann Candler James Madison Candler George Washington Candler Thomas Jefferson Candler Elizabeth Candler shall Live with my wife until they arrive to Lawful age and be maintained on the Proceeds of the Land and Stock allotted to my wife Polly with Elizabeth Roberts a bound girl to me

5th It is my will and desire that my daughter Lucinda Candler may Live with her Mother until she marries if they can agree and I give her one Cowe and calf and one feather bed and Furniture out of my present Stock and one black Walnut chest and one horse head worth fifty dollars.

6th It is my will and desire that my obligation to the County Court of Beaufort as respects the above named bound children that are bound to me should be fully complied with

7th It is my will and desire that after all my Just debts are Paid off that all the Remaining part of my Estate be Equally divided amongst my Children that are then Living and those of my Children that are dead their heirs to get Their part Except the land and Stock and furniture allotted to my wife for the Support of her and the children and at her death or Marriage then Sell all the Land and Remaining House hold and kitchen furniture and Stock of all kinds and working tools that she may have or hold or divide it as it may seem best amongst the heirs

8th I also appoint George Washington Candler Charles Moore David Fareneworth of Buncombe County and James R. Loxe of Haywood County all of North Carolina as Executors of this My Last Will and Testament as witness my hand this 23rd Day of July 1844
