In the name of God, Amen. I, Christian Avendshine, of the County of Cabarrus and State of North Carolina, being very sick and weak of body, but of perfect mind and memory, Blessed be God for the same, considering the mortality of my body, and that it is appointed for all men once to die do make and ordain this my last will and testament. First I give and recommend my soul into the hand of God that gave it and my body to the earth to be buryed in decent like and Christian buryal at the discretion of my executors nothing doubting but at the general Resurrection I shall receive the same again by the mighty power of God and as touching such worldly estate wherewith it has pleased God to bless me in this life I give devise and dispose of the same in the following manner and form.

First I will that all lawful debts and funeral charges be paid.

Secondly I give and bequeath to my dearly beloved wife Catron

Avendshine the benefit of my dwelling house wherein I now live and her bed and and furniture and her chest and all the clothes and spinning wheel with one good cow and calf and all my household furniture that she chooses to keep and the benefit of her garden and one fourth part of all kind of fruits which doth hereafter grow on my orchard if she chooses that much all which articles I give and bequeath to my beloved wife Cathran during her life and at her death to bequeath the said property to whoseever she will and also I give and bequeath to my said wife ten pounds hard money out of my estate.

Avendshine, the plantation whereon I now live containing one hundred and sixty three acres of deeded land with the improvements thereon to him and his heirs forever. And also all the fences that was first made to the said old improvements which now falls in my daughter Catherins land.

Fourthly I give and bequeath to my dearly beloved daughter,
Cathrin Propst seventy acres of land whereon she now lives to be by her
freely cultivated until her son Henry comes to the age of twenty one years
and then said land joining Kresses land and Safrits land fall to her son,
Henry to him and his heirs forever and all the rest of my estate to be equally
divided amongst all my children, namely Rinehold Avendshine, Darity Culp's
children, Madlena Slough and Catrin Propst. And I also give to my granddaughter
Catrin the sum of ten shillings to be levied out of my estate.

And I do constitute and appoint my trusty friend Goseph Shinn and Rinehold Avendshine my executors of this my last will and testament and I do utterly revoke and disannull all other former wills and testaments. In witness whereof I have hereunto set my hand and seal this nineth day of April in the year of our Lord one thousand seven hundred and nenety three and in the seventhenth year of our independence of -----?

Will of Rinehold Avenshine.

In the name of God, Amen.

I, Rinehold Avenshine, of the county of Cabarrus and State of Morth Carolina being of perfect mind and memory do make and ordain this my last will and testament and first I will that all lawful debts and funeral charges be paid.

2nd I give and bequeath to my dearly beloved wife, Rosina Avenshine, her bed and furniture thereunto belonging her flax wheel one horse her choice and her saddle and bridle her reel and woolen wheel and my large walnut chest and a small pine chest and two cows and calves her choice of my stock and one iron pot her choice and onehalf of all the linen flax cotton, wool and yarn that I may be prospered of at my death and one pair of cotton crads and one plough and tabkling for two horses her choice and the benefit of my plantation whereon I now live during her natural life or widowhood and at her death or marriage the plantation to be returned to my daughter, Catherine, and the above mentioned property to remain to my wife and her heirs forever.

3rd I give and bequeath to my daughter, Catherine Avenshine the plantation whereon may mother now lives to her and her heirs forever together with her bed and furniture and her chest and a small ----? and one horse her choice after her mothers choice and saddle and bridle and the three heads of cattle that she now claims and my loom and all the tackling thereto belonging and the other half of all the linen, cotton, wool flax and yarn above mentioned to her and her heirs forever and her and her mother to pay to my mother, Catherine Avendshine all for her maintenance that I am bound to pay during her natural life out of the said two plantations.

4th I give to my son, John Avendshine one horse that he now claims and a good saddle and bridle and fifty acres of land joining the land of Carthyser and Simback and John Misenheimer to be laid off to the best advantage not to damage the old tract and him to pay his equal share of my mothers maintenance with my wife and daughter.

5th I give and bequeath to my sister Catherine Propst son Menry
Propst about eighty acres of lamd joining and between the lands of John
Misenheimer Charles Sefried John Suther and my father's old tract it being the

land that my father Christian Avendshine alloted to said Menry Propet, a son of my sister Catherine Propet.

then and in that case the lands that I have given to my said daughter it is my will that my sister Catherin's son Michel Propst shall have the remainder of my father, Christian Avendshine's old plantation, to him and his heirs forever. And also I give to my said son, John one good ax and mattock and all the the remainder of my estate not yet mentioned to be sold by my executors after my death and the money arising therefrom to be equally divided between my wife Rosina and my daughter, Catherine to them and their heirs forever.

And I do hereby constitute and appoint my trusty friends Joseph Shinn and Abraham Misenheimer the executors of this my last will and testament and I I do utterly disallw, revoke and disannull all other former wills, Testaments, legacies bequests and executors, ratifying and conforming this and no other to be my last will and testament.

I do hereby leave and bequeath to my son, James the right and title of all the lands which I possess exclusive of a part in the other pfrmy Estate.

and I do likewise leave to him all the money or debts belonging or coming to the Estate exclusive of his part in the remainder of my Estate of which my son James is t son James is to pay all debts or demands against my Estate out of his part of my Estate and I hereby leave and bequeath to my wife her living on the land while she lives, and I do leave to my wife a negro boy named "Ben", to her use her lifetime and at her death to be left to my son James as part in his share, and I leave and bequest to my wife the Bald Morse and her saddle, and

I do leave and bequest to my son James the grey stud-horse and I do leave and bequest to my three daughters each of them a horse, saddle and bridle, and I do leave and bequeath to my wife and each of my daughters two cows each and to each of them a bed and bedding of cloth, and I do leave and bequest and allow the Property of my son James and wife and each of my daughters to be valued exclusive of land and money, and all the remainder of my property to be sold and to be divided amongst my wife and son, James, and each of my daughters so as all will have an equal share exclusive of the land and money left to my son James, and I do likewise leave to my sons, Francis and Robert out of my whole Estate the sum of Five pounds each. My son, James to be my executor.

Since I, Catherina Abenschein, born Behringern, through the goodness of God, now have a very great age, I therefore can not presume that my years or days of life in this world will be many more; so I thank the good God for all the many graces and mercies granted to me, and beg Him when it shall please Him to take me away from this temporal life to have mercy on my poor soul; also have firm confidence in my friends and neighbors that they will then in a decent and Christian manner consign my examimated body to earth.

Since it has pleased the wise God to call all my children, except one living daughter, into eternity, before me, and this still Adaughter is now my only refuge, consolation and assistance, also the same gladly supports me, and as a good child, assists me in my old age, so I consider it right and just to prove myself grateful for this as far as possible according to the condition conditions of my feeble temporal possessions.

As I now, thanks be to God, find myself with good faculties of body and soul, so that I can now fix a certainty over my inheritage after my death, soelforder, for the avoidance of all disagreements after my death, the following as my last will and intention, and will that the same after my death will be exactly brought into fulfillment. I, therefore, order and will that after my death "My daughter's oldest son, Heinrich Probst, out of my inheritage shall have and keep for himself as one tin bowl, one tin platter, two tin plates, six tin spoons, and the Trutschen stove.
