Will of Samuel Morton

In the name of God, Amen.

I, Samuel Morton, of the State of North Carolina and county of Cabarrus, being in a weak state of body but sound in mind, memory and understanding, calling to mind the mortality of my body, the shortness of life and the certainty of death, have thought fit to make my last will and testament in form and manner following, viz-

First- I resign and commit my soul into the hand of Almighty God who gave it hoping to find mercy and forgiveness through the merits of our Lord and Saviour, Jesus Christ, and my body to the earth to be interred in a decent Christian manner at the direction of my executors nothing doubting but I shall again receive the same at the resurrection of the last day. And with respect to the things of this life which God has blessed me with, I will that they be disposed of as follows-viz,

First That all my lawful debts be completely paid and discharged.

Item-I give and bequeath to my loving wife, Ann Morton, all my moveable property; likewise all notes or bonds for money and what money I have at present, likewise my dwelling house, firewood, and her choice of my books as far as six, also that my two sons, Samuel and William give her a sufficient maintenance off the land during her lifetime.

Item- I give and bequeath to my oldest son, Robert Morton, the sum of five shillings.

Item- I give and bequeath to my second son, John Morton, the sum of five shillings.

Item- I give and bequeath to Samuel Morton my third son, one half of my land, one half of my clothing and one half of the remainding part of my books.

Item- I give and bequeath to William Morton, my fourth son, one half of my land, one half of my clothing and one half of the remaining part of my books also the smith tools to him and his eldest son after him, living.

Item- I give and bequeath to James Morton my fifth son the sum of five shillings and provided he shall return home whatsoever his mother shall see proper to leave him at her decease.

I likewise appoint prdain and constitute my loving wife and William Morton, my son to be the sole executors of this my last will and testament.

And further I publish, pronounce and declare this as my last will and testament renouncing and disownong all former will and testaments made by me or by my order and only as my last will and testament do acknowledge these presents, given under my hand and seal this twenty ninth day of July, A.D. 1799.

Will of Robert McMurrey

This my last will and testament, I execute this eleventh day of February in the year of our Lord one thousand, seven hundred and ninety-nine, Amen.

Secondly- I order all my lawful debts to be paid out of my estate.

Fourthly- I bequeath unto my negro, Tom, his freedom at the death of Eleanor, my wife and that he he emancipated according to law and likewise, I bequeath him, said Tom, one hundred silver dollars to be paid out of my personal property at the time of his emancipation. I likewise constitute my son, James McMurrey as guardian for said Tom.

Fifthly- I bequeath unto my son, James McMurrey my son, my negro boy, named Jacob.

Sixthly- I bequeath unto Francis McMurrey, my son, my negro girl, named Emmy.

Seventhly-I bequeath unto my son-in-law, James Fleming, five shillings sterling.

Eighthly- I bequeath unto my son-in-law, Volluntine Kirkpatrick, five shillings, sterling. likewise to his wife, Martha, five shillings, sterling.

Ninthly- The remaining parts of my moveables with the plantation to be sold at public sale and to be equally divided with my money into five shares viz, James McMurrey, Francis McMurrey, Robert McMurrey, Robert Fleming and Eleanor Buzzy, likewise all my books to be equally divided among the above mentioned legatees.

Tenthly- I order this my last will and testament to be executed by James McMurrey and Robert McMurrey as executors in witness whereof I have hereunto set my hand and seal the day and year above mentioned in presence

And first I do give and bequeath to my dearly beloved wife, Rebecah, all my real estate that is my land by her to be possessed and enjoyed during her natural life and likewise all my personable property without exception by her to be possessed and enjoyed during her hatural life and after her death, I do give, bequeath and devise my real estate, that is my land, to Joell Guillams and the lawful heirs of his body to be possessed and enjoyed forever and my personable estate to be at the disposal of my beloved wife, Rebekah, at the decease of her natural life. June 28th in the year of Cabarrus County our Lord, one thousand and eight hundred and twenty four, I, Dorothy Milnster, widow of the said state and county being of sound disposing mind and memory but old and weak in body do make and ordain this and only this to be my last will and testament hereby revoking and making void all others in manner and form following, viz - To my oldest daughter Barbara Russell living in Buncom County I give and bequeath my red and blue coverlet and a striped counterpane striped with copperas and blue, to my daughter Hannah Brian, a blue coverlet and a homespun blanket. To my daughter, Polly Mysenhimer one coverlet with fringe below, one counterpane with blue, white and copperas. To my daughter, Elizabeth Milnster one calico bedquilt and a cast up counterpane with nice fringes and all the dresser ware that I own or may own at my death, one pine chest with lock and key, to my daughter, Elizabeth. To my son John Milnster I give one bedstead turned? one feather bed one chaff bed, one sheet and two pillows and a blanket homespun. Also I give my daughter, Elizabeth one rose blanket and all my sitting chairs. To my sons, David and Washington Milnster I give the sum of twenty five cents each to remind them that they once had a mother. My bed and furniture in which I now lie shall be sold every article seperate thereunto belonging and the proceeds equally divided among the heirs except my sons, David and Washington and my clothes shall be equally divided between my four daughters, Barbara, Hannah, Polly and Elizabeth and what bed clothes not mentioned in this to be sold except the sheets which I give to Elizabeth Milnster except the one already mentioned to John Milnster and one to my own bed and I hereby appoint my son John M. Milnster my executor to this my last will and testament and to this my will I set my hand and seal the day and date above written in the presence of
