Thos Dogier In the name of God Amen I Thomas Dogier of the County
of Camden & State of North Carolina being of Sound and
Perfect Mind & Memory Blessed be God do this 2^d day
of November in the Year of our Lord Eighteen hundred
and Thirty three make & establish this my last Will &
Testament in manner & form as follows

I bequeath the use of all my Estate both Real and Personal
in doors and out doors and of every kind whatsoever after
paying all of my Just debts unto my Beloved wife during
her natural life & no longer & after her death

Give unto my Step Son Wilson G. Lamb one negro man
named George one negro Boy named Isaac one negro
woman named Nancy and Girl Delia I also give unto my
Step Son Gideon Lamb one negro woman Dolly and

Boy Alfred after the death of my said wife Henry
and if either of them should depart this life under age
or without leaving any lawful Issue then my Will is
that the surviving one shall inherit all and I give unto
my said Step son Wilson G. Lamb all of the Lumber and
Cypress Swamp that I Purchased from the Heirs of
Hicks Grandy decd and I also give the Cypress Swamp
adjoining the land of Haywood I Bell & others which
part or share thereof that I am entitled to unto my Step
son Gideon Lamb upon this proviso that my Executors
shall have full power and Authority if need be for want
of a Sufficiency of other property to pay all of my Just
Debts that is belonging to my estate to sell any of the
above Legacies or parts thereof as they may choose for
the purpose of paying my said Debts

I give unto my two Nephews Andrew S. Dogier and
James Grandy one negro Man named David & if either
shall depart this life under age and without leaving
any Lawful Issue then & in that case I give said negro
David of on said unto the one that shall survive the other
I leave the Land I purchased from Wails Cooper to be sold
by my Executors in case there is not enough property belong-
ing to my estate to pay my Just Debts not given away in
the body of this Will the House hold and Kitchen furniture
excepted & the residue of the proceed of the Sale thereof
after paying the Balance of said debts if there shall be
any such balance wanting I give the said residue of
the Sales of said Tract of Land of on said If any there be
unto my two nephews of on said. Andrew S. Dogier and
James Grandy to be Equally divided between them share
and share alike & if either of them depart this life without
leaving any Lawful Issue then my Will is That the sur-
viving one shall inherit the others said share
My Will also is that if there shall be property enough belong-
ing to my estate not already given away in the body
of this Will to satisfy & pay all my Just Debts without
the above described Land that I purchased from said
Wails Cooper & on said then I give the said Tract

Thomas Dager of Land unto my two nephews as aforesaid Andrew
 A. Dager and James Grandy to be equally divided between
 them & if either of them depart this life without leaving
 any Lawful Issue or under age then I give the said tract
 of Land with all that appertains thereunto unto the one
 that shall survive

Item I leave all of my stock of every kind that my beloved
 wife can spare & all the house hold & kitchen furniture
 that she also can spare with all the Lumber that is on
 hand to be sold by my Executors & the Proceeds of the sale
 thereof to be applied by my said Executors to the paying
 of my Debts also all the notes & money that shall be
 left on hand

And I hereby appoint and nominate my worthy friends
 Wilson G. Lamb & John D. Grandy and my beloved wife
 Mary Dager Executors & Executrix to this my last Will
 & Testament and I hereby authorize and empower them
 to sell the property of my estate set apart in the Body
 of this my last Will & Testament for that Purpose either
 at Private Sale or Public as they may deem most
 expedient In Testimony whereof I have hereunto set
 my hand and Seal to this my last Will & Testament
 Acknowledging this to be my last the day & date first
 Written

In the Name of God Amen I do this day of the County
 of Camden & State of N. Carolina being in perfect sound
 mind & memory thanks be given unto God calling unto mind
 the mortality of my Body and knowing that it is appointed
 for all men once to die I do make and publish this
 to be my Last will & Testament disavowing all others
 Wills & Gifts heretofore by me made & given & dispose
 in manner and form as follows

in the first place I bind the use of one third part of the man-
 or plantation & Land whereon I now live unto my dearly beloved
 wife Lydia Kinaday her natural life or widowhood only
 reserving a small piece that I cut off by a line from a
 Black Gum to a holly tree containing about three or four
 acres for the use of Darcas Jones whereon she now lives
 also I bind the use of one Leather Bed & Furniture her share
 one wheel & one pr of Dog Irons & Sings her natural life
 or widowhood & sufficient support for one year & family
 I give & bequeath unto my dearly beloved son William
 Kinaday all that Tract or piece of Land whereon I now
 live only three or four acres that I cut off as above
 stated from the black Gum to the Holly Tree that I bind
 to Darcas Jones then after the death or marriage of my wife
 Lydia Kinaday then the whole unto the said William Kinaday
 also the Leather Bed & Furniture one pr Dog Irons Sings that
 I bind to my wife unto him & his heirs forever
 I give & bequeath unto my dearly beloved daughter Lydia Kinaday all
 that piece or Tract of Land lying in swamp containing about
