I give to my daughter Parmelia Willis all the prechises there and the animals belonging. I give to my daughter Parmelia Willis three feather beds and bed in furniture and also all of my house furniture and kitchen furniture also the fifty acres of land that lies back of all my other land and also I give her a note on Joseph Pinn for seventy Dollars dated the twenty fifth day of August Eighteen Hundred and thirty two also one note of land on Elijah Pinn for fifty Dollars dated the twenty six day of October Eighteen Hundred and thirty three - also one Corn and Calf gave also the remainder part of my pasture also my division that my Bankers land be equally divided between my daughter Laughton Jess Lane Kitting Wade Isaac Willis Henry Wade and Parmelia Willis and I give to my two sons George W. Willis Robert Willis fifty acres apiece. I also give my daughter Gaskins fifty cents and here by I leave my Son as John S. Howard and Joshua Simpson Executor to this my last and testament in writing whereof I the said Daniel Willis hereto to this my last will and testament - set my hand and do the day and year above or within mentioned
