During her life or widowhood I also give and bequeath unto all my children five shillings for each child to be paid unto them at their freedom age by my Executors.

Lastly I leave Mitty Gillikin my said wife to be Executor of this my Last will and Testament Hereunto I have set my hand and seal this twentieth ninth day of March in the year of Our Lord 1808

I Chiles Green Being sick and weak of Body but of sound Perfect sense and memory do make and ordain this my Last will and Testament. First I Recommend my Soul to God and my Body to the dust and for what worldly God has blest me with my will and Desire is that they shall be disposed of in the following manner - Item I give and bequeath unto my Loving Daughter Esther Hatarell one old negro woman named Patience to her and her heirs forever Item I give and bequeath unto my Grand Daughter Mitty Green one Fisher-hill and her heirs and all the Furniture belonging to it to her and her heirs forever Item I give and bequeath unto my Grandson James Matthews Thirteen Acres of land one Fisher-hill all which he has already in Possession to him and his heirs forever Item it is my will and Desire that all my cattle that I have after these names are taken out that was given to me by my Husband's will should be Equally divided between my Daughter Esther Hatarell and Phoebe Moore and my Grand Daughter Mitty Green and my Grandson Jonathan Brown that is my 2^d Grand Children both of them to have one share equal to one of my Daughters also it is my will and Desire that all the cattle that was given to me by my Husband's will should be Equally divided between all my children to wit Zachus Green Archulus Green Esther Hatarell and Phoebe Moore - to them and their heirs forever.

Item it is my will and Desire that my son Archulus Green should have Seven Hundred wt of Pork and fifteen Barrels of corn for one years support Item I also give and bequeath unto my 2^d son Archulus Green one small Piece of Land which I set off Tobey wecks, joining his Plantations to him and his heirs forever Item I give and bequeath unto my son Zachus Green Two Hundred and Twenty acres of Land on the Great Lake to him and his heirs forever Item it is my wish and Desire that after all my just debts is paid that all the Remainder of my Property that is not here mentioned should be divided in the following manner one third to my Daughter Esther Hatarell one third to my Daughter Phoebe Moore and the other I give unto my two Grand Children Jonathan and Mitty Brown - to them and their heirs forever and Lastly I do constitute and appoint my Loving son Zachus Green and William Hatarell Executors unto this my Last will

and Testament. Revoking and making null and void all former wills By me made and acknowledging This only To be my Last will and Testament In witness whereof I have hereunto set my Hand and Seal This 23rd day of December 1805

I lend unto my beloved wife Martha Gillikin all my household Goods and moveables with my house and plantation with all of my land her lifetime.

I give and bequeath unto my Daughter Anna or her heirs five shillings to be paid by my Executors at my Decease

I Give and bequeath unto my son Joseph Gillikin or his heirs five shillings to be paid by my Executors at my Decease

I Give and bequeath unto my son Aaron Gillikin or his heirs to be paid by my Executors at my Decease five shillings.

I Give and bequeath unto my Daughter Rhode five shillings to be paid by my Executors at my Decease.

I Give and bequeath to my Grand son Jesse Gillikin two Heifers and this increase by this mark over slope the right-ere

I Give and bequeath unto my son Amos Gillikin or his heirs five shillings to be paid by my Executors at my Decease

I Give and bequeath unto three of my Children here named my Daughter Zilpha and my Daughter Loris and my son Uriah Gillikin which three named I give and bequeath all of my moveable property which I have with away at the Decease of my wife there is one hundred and fifty acres of land which I purpose of selling of if not sold before my Decease the land that is called the four ridge which land is to be sold at auction and my wife to have the money for it these three Children here named my Daughter Zilpha and my Daughter Loris and my son Uriah Gillikin which Property here named I Give and bequeath unto them and their heirs for ever to be equally divided among them three here named and their heirs to have and to hold in quiet possession this my last will and Testament Lastly I do make and ordain Uriah Gillikin and Thomas Russell to be my Executors as witnesses my hand and seal this the last day of January One thousand and Eight hundred and Twelve
