 will and Testament in manner and forme  
 following.

First I Commit my Soul into the hands of  
 God that gave it me Hooping through the  
 Merites of my Blessed Saviour to Receive free  
 pardon of all my sins ~~in~~  
 Imprisonment I Give and Bequeath to my  
 son Allen Backhouse the west part of the  
 manner plantation I live on after my wife  
 Mary has lost her third D-ngher Natrall  
 life as follows Beginning at the mouth of the  
 Spring Branch near the Dwelling House and  
 Running up the Hollow of the Spring branch  
 through the orchard to a marked pine on the  
 Back side of the 1<sup>st</sup> orchard thence a S<sup>e</sup> Course  
 to the Back line to him his Heirs and assigns  
 for ever - Item I Give and Bequeath to  
 my son John Pugh Backhouse the East part  
 of the plantation Beginning at the mouth of the  
 Spring and Running the Courses before mentioned  
 and that line to be the Dividing line Betwixt  
 my two Sons to him his Heirs and assigns  
 for ever Item I give to my wife Mary  
 Backhouse my two sons Allen and John Pugh  
 and three Daughters Ketty Sarah and Mary  
 all my Negroes and their Issue to be Equly  
 Divided amongst Them like wise sheeps  
 Cattle and Hogs Household Goods to be  
 Divided Equly amongst Them when my son  
 Allen comes to the age of Twenty years old  
 to them their heirs and assigns for ever my  
 will and Desier is if my son Allen should  
 Depart this life before he comes to the age  
 of Twenty at his Deth my Executors to make  
 the above Divission my Desier is for my  
 wife to keep all the Negroes and stock  
 on the plantation to school and Raise  
 the Children - - -

My Desier is for my Executors to sell my  
 piney land I Bought of John Russell

and all as three pieces of land Intra not great part  
 to pay my Debts and should my Children sell my two  
 salt plates after the year is out with an shore & Barne  
 I do Here by settherly Revoak Dissolve Dissanull all  
 and Every former wills Bequeaths Ratifying and  
 Confirming this and and no other to be my last  
 will and Testament ~~made & ordain my heirs Executors~~  
 Solomon Shepard and Samuel  
 Chapman and my son Allen Backhouse in witness  
 where of I the s<sup>r</sup> John Backhouse Have Hereunto  
 put my hand and Seal this Twentieth of fe- Day month  
 one Thousand Seven Hundred and Eighty two
