 it is once appointed for all men once to die I do make my
 Steadfast and of Daim this My Last Will and Testament in the
 manner as followeth is to say first of all I Give and Command
 my Soul into the Hands of Almighty God that gave it and
 my Body to be Decently Buried at the Discretion of Executors
 in a Christian like manner and Touching such things
 as it has bin Please God to Bless me With I give in the
 New as follows after saying all my Lawful just debts to be
 Paid and Bequeath to my Beloved Wife the Dwelling house
 I now Live in With one third Part of my Lands and Moveable
 Estate of Every kind During her Natural Life or Widghood
 and at her Marriage or Decease to my Daughter Casandra
 all the Moveable part afore Mentioned to her I Give
 and her heirs for ever With one Lot in Swans Run to be
 sold to Purchase a good Negro woman for my said Daugh-
 ter and if she Deceases without Lawful issue then to be
 Equally Divided between the others of my children

N.B. I'm - My Beloved, I further give as in the manner
 as above mentioned two Negro boys During her Natural
 Life or Widghood and at her Marriage or Decease I'm to be
 Jo to Easter Green my My Daughter and her Lawful heirs for
 Ever and I'm My Daughter (Livia) to be at this place
 another of my Negro boys Land which is on the East side of
 White Oak River I give as follows

I'm My Sons Zachus Green and Archelus Green to be
 Equally Divided he to have them both and their heirs for
 Ever the Lawful Rebatter of their own Body and my other
 Moveable goods that is to say my House hold furniture and
 Store of Cattle Horses and hogs to be Equally Divided
 betwixt my two sons and three Daughters I also I'm my
 Grand son Jonathan Green Give and be Quoth one hundred
 acres of Land on the Head of White Oak River or near
 thereabouts I Now Constetute apyment and ordain
 my Dearlly Beloved Wife Elsie Green and Zachus Green
 My Lohs and Soul Executors in Witness where of I
 have hear Unto set my hand and Seal to ful fill my will
 to all intents and purposes this Eighteenth Day of
 September anno domi 1789

Test Benj a Telford C. C.

In the Name of God amen I John Garner of Hertford County in the State
 of North Carolina, Planter being in in and weak in body but of sound mind
 and memory and looking to mind the mortality of my body that it is app-
 pointed unto all men once to die Do make and ordain this my Last
 Will & Testament in manner and form Following viz I Command my soul
 into the hands of all mighty God that gave it hoping through the merits
 and mediation of my blessed savior to receive free pardon of all my sins
 and my body to be buried in a Christian like manner at the Discretion
 of my Executors nothing doubting but at the General Resurrection I shall recei-
 ve the same again and to such worldly goods or estate as it has pleased
 God to endow me with I give and dispose of as hereafter mentioned.

First I give unto my beloved wife Lucy Garner one half of my Land and moveable
 property during her Lifetime or widows hood and to keep my son and if
 at her Death or Marriage for him to purchase the Land.

2 I give unto my son William Garner the other half of my Land taking his
 half of the eastward part dividing the said Land by a narrow line with the
 others. I my desire is at my wife's Death that my moveable property should
 be Equally Divided amongst my 6 children that then a living.

Lastly for the better executing this my will I nominate and appoint my
 said wife and son Lenny Garner and William Garner my Executors to do
 same utterly Revoking & Denying all Wills before made or in answer to
 be made by me acknowledging this and no other to be and contain
 my Last will and Testament In witness where of I have hereunto
 set my hand and affixed my Seal this 20 Day of March Anno
 Domini 1794
