Also I give and bequeath unto my beloved infant John Oglesby the use of the within mentioned negro girls Moll and her being her widowhood and stock of all kinds and the use of part of lands I have given to my son Thomas and they till they come to age their maintenance during her widowhood and furthermore in my will and desire that if any of my sons should die or daughter before they come to age or without heirs their lands be divided amongst the sons and stock also and likewise the kids Estate in like manner the girls and further this is my will and desire that at the death of my beloved wife or marriage all the above mentioned stock & lands which I have given before it be to be equally divided amongst my children. Lastly I nominate my son John Oglesby and Nathan Allen Executors of this my last will and Testament to wit whereof I have hereunto set my hand and seal this eighth of December 1796.

In the name of god our savior I John Oglesby of the County of Dorchester in the State of South Carolina being every awake and Lord of Body out of my full sound mind and memory And desiring to obtain the satisfaction of my Body being it is appointed for all men to die do make and publish this my last Will and Testament in manner and form as followeth First of all I Commit my soul into the hands of almighty god that first gave it and my Body to its dust from whence it Came Hoping for Free pardon for all my sins through Jesus Christ my Redeemer. Secondly my Body to be decently Buried in a Christian like manner. Thirdly my will and desire is that all my just debts be first paid, I am give as followeth First I Lend unto my Loving wife during her natural life the young of my money plantation whereon I now Live I also give her my one and three Tether Heads and Twinties then being the same that I have by her for also I give her one horse man being the same that I had by her also I give her my said wife three Cowes Philadelphia harts and Goat and sheep shate yearlings and one Cow named Brad and her Calf and one Cow named Cheary and her Calf also shee Breeding hower which she is to have choise of all my flock of hogs except them already given away all of the above articles and things mentioned given to my wife I give and bequeath unto her and heirs and assigns forever

I also Give to be allotted out of my stock of hogs as many of the best of them as will when fallow make twelve hundred weight for the support of my Family the ensuing year also I Love the young of my hound and the Cattle and the choise of my stock to take two young heads to Breake for plantation young jointly between my wife and my two sons Daniel and John Oglesby which said O'ldon and Hears and Cattle I give unto my wife Nancy Oglesby Daniel and John Oglesby to them and their heirs and assigns forever.

Next I give and bequeath unto my son Daniel Oglesby all the piece of Land that I bought of Benjamin Oglesby lying on the North side of hells Swamp containing one hundred and fifty acres be the same more or less also I give him said Daniel Oglesby all the lands I own lying on the South side of Newport River more or less more by the name of Greater Neck being part of a tract patented by Ephraim Chadwick also I give him one hundred acres of land lying on the South side of Newport River near the place now being the same that my father gave me in his last will and Testament. also I give him the fifty acres of land adjoining to the same which I took up and patented. I also give him my said son Daniel one corner Mor named Sam But I leave at the privilege of the Colle to suck her until the said Colle is over four old, also I give him two Tether Heads and further the
