declaring this to be my last will and testament

with all the appurtenances also all my land on Hog Island
with at the death of my wife Dorcas Gaskill. I further
give unto the said Jerry Sulford and Jane Ann Gaskill
all my personal property at the death of my said wife
Dorcas Gaskill said personal property consists of
and appurtenances nets hair hold and kitchen
furniture with all my Coppernails tools &c.

I loan to my wife Dorcas Gaskill my house and
where I now live also I loan to her my site to the
on Hog Island part. I furthermore loan to her the
Dorcas Gaskill all my house holds and related in part
with all the rest of my personal property to her the
Dorcas Gaskill for her use during her natural lifetime

I do hereby constitute and appoint my trustee
John L. Goodwin and Geo. W. Emory executors to the

of the said State and County

do make and ordain this my last will and testament
1st I give and bequeath to my son Sandolph Daniels fifty
acres when he now lives and forty acres lying to the back
part of the wolver den and twenty five acres back of the
great pond, and sixty acres lying between the head of the bay
and Swan point fifty ~~and~~ acres of marsh called the beach ridge
which I give to my two sons Sandolph Daniels and Esom
Daniels, I also give Sandolph Daniels one bed which he has had
I also give to my son Sandolph Daniels one canoe and also my
site to the house on Long Banks,

2nd I give to my Daughter Clarissa Daniels one bed which
she has and five dollars in money.

3rd I give to my son Esom Daniels the place when I now live
one hundred of land lying on the back west side of the north
bay one bed and bedstead and my site to the Nets and my
site to the horse at the North bay and my working tools

4th I give to my Daughter Delila Daniels one bed and bedstead
one cow and calf her choice and also two whips and also my
