All of my just debts shall first be paid.

I give and bequeath to my daughter, Daisy, R. Hatzell, all of my Household Furniture, to have and to hold the same to her and her executors, administrators and assigns forever.

I also give to her all my legal interest in the Dwelling House, land and appurtenances, situated in the Town of Blaufort County of Carteret and State of North Carolina described as follows: Being a part of Lot No 58 Old Town, beginning at a point (50 ft) fifty feet South from the Corner of Queen and Ann Sts, on the Westward boundary of Said lot #58, thence South Wardly along the Western boundary of said Lot to the Allen Davis lot, or Southern boundary of lot 58, thence easterwardly along Southern line of Said lot to E. W. Richardson line thence Northwardly with E. W. Richardson line to W. H. Hendricks line, thence Westwardly along W. H. Hendricks line to the beginning, To have and to hold the same to her and assigns forever.

And lastly I do nominate and appoint my Said daughter Daisy, R. Hatzell to be

the executrix and administrator of this my last Will and Testament without bond.
