Mariner, do make and declare this my last will and
Testament in manner following—

First I resign my soul into the hands of almighty God
hoping and believing a Remission of my sins, by the
Mediation of Jesus Christ; And my body I commend
to be buried at the discretion of my executors here
named, and my worldly goods & estate I give
as follows—

First I give and bequeath to my father Thomas
Carpenter in Kent County in Maryland, all my
worldly goods and Chattels of what kind soever I
at this present time possessed of to him and his
lawful heirs forever— Except a silver watch
which I give and bequeath to my brother Thomas
in Maryland, my intention herein is that the said
Legacy to my father I desire may be applied to the
of my brethren and sisters now living to their own
use and behoof.

Lastly I appoint my friend Benjamin Blay
be my sole executor to this my last will & Testament
hereby revoking all wills by me heretofore made
in Witness whereof I have hereunto set my hand and
seal this Seventeenth day of October 1784.

ing it once appointed for all men to die do make and ordain this
my last will and Testament in manner and form as follows, to wit—

Land with all there Improvements, But do send unto my Loving wife
Sarah Smith the plantation where I now live or any other part of
my Land that she chooseth to settle on during her Remaining my Widow
Here I give and bequeath unto my Loving daughter Mary Smith
and Sarah Smiths Three Feather Beds and furniture and all the
Remaining part of my household goods and eleven head of
milk to be equally divided between them But do send the
unto my Loving wife to enable her to rear my children during her
Remaining my Widow and my desire is that the Remaining part
of my Estate be sold and after all my just debts is paid the
Remainder part I give and bequeath unto my Loving wife Sarah Smith
and Lastly I do ordain and appoint my Loving friend David
Russell Executor and my Loving wife Sarah Smith Executor
unto this my Last will and Testament, Revoking and making
null and void all former wills and Testaments by me made
and acknowledging this only to be my Last will and Testament
In witness whereof I have hereunto set my Hand this 13th
of June 1787.
