 mind, and memory do ordain this my last will and testament that
 to say first of all I do give at my death to my son David Garner
 house and land where I now live, and the following articles in
 the house that is, the desk, set of chairs big, little, barfoot, one box and
 table, one straw yellow bag, one large glass, stand saw, one chest and
 small box, and furniture, one Stephen the grindstone and the hand mill
 give to my daughter Ruth Garner the bed and furniture which I sleep on
 one box & dressing table the leather box and dressing, one stay and one
 hat, I give to my daughter Esther Garner and bed and furniture
 one box & dressing table, and dressing, to my two sons William, and
 Judham Garner, I do give one Shilling apiece each, also I give to my
 daughter Polly Chidman one Shilling apiece each also to my daughter
 Mary I do give one Smales bed, all of my other property of every
 kind and value which is not mentioned in this will I do leave to be
 sold at public sale by my Executors and all of my Just debts to be paid
 at the same and what is left after the debts is paid to be equally divided
 among my children except William & Judham and my daughter
 Polly Chidman to whom I have given one Shilling each to be paid them
 by my Executors as the full legacy of my estate and I hereby declare
 and affirm this to be my last will and testament & I disavow & revoke
 all other wills or writings whatever to this effect. I therefore
 do hereby ordain constitute and appoint my son David Garner
 my sole Executor to this my last will and testament to execute and
 perform according to the meaning & intent thereof without
 Reason or any manner of Abstraction, whatever, in testimony
 whereof I the said William Garner do hereunto set my hand
 and seal the 31st of December in the year of our Lord one
