

In the name of God Amen, The eighth day of Jan one thousand eight hundred and fourteen.

I Henry Krin of Carleton County & State of North Carolina being in a low state of health but of sound mind and memory do make this my last will and testament; at the same time utterly revoking all former wills made by me, acknowledging this to be my last will and testament.

First I authorize my executor to sell one tract of land of mine lying on the north west side of Hasnets Creek whereon William Watson now lives containing two hundred acres which will come full from the land now in my possession in any way he may think proper to the best advantage, also immediately after my death to process and sell all my personal estate of every kind whatever.

2nd I give and bequeath unto my loving wife Mary Krin, one third of the amount of sales of the above land also one third of the amount of sales of the above mentioned personal estate, to her and her heirs for ever also one third part of all the money I may at my death have on hand & one third of all the money that is due me to her and her heirs forever. I also leave unto my loving wife Mary Krin one third part of the plantation whereon I now live lying on Pettigrews Creek containing ninety acres her third to include the house & cleared land during her natural life.

Thirdly, after the death of my wife Mary Krin I give and bequeath to my daughter Natty Krin the above mentioned plantation on Pettigrews Creek containing ninety acres to her and her heirs for ever, but should she die before she arrives to the age of twenty one or has an heir lawful of her body then I give and bequeath to Eljah Pappas son of Joshua Pappas and the above mentioned plantation to him and his heirs forever.

Fourthly, I give and bequeath to the daughter Natty Krin all the remaining part of the money arising from the sales of the above land and personal estate also the remaining part of the money I may have on hand and add due me to her and her heirs forever, but should she die before she has a lawful heir of her body or arrives to the age of twenty one, then I wish whatever money may be due her in the hands of her Guardian should be equally divided among the

heirs of Joshua Pappas namely Eljah, Polly, & Mary & Joshua Pappas.

Fifthly, It is my wish and desire before my property is divided, that my Executor should pay to a teacher himself for twelve months schooling of my daughter Eljah. Also the wife of Caleb Bell and that all my just debts should be paid & my Executor satisfied for his trouble.

Lastly I wish my daughter Natty to receive necessary schooling and to be taken care of out of what I have here bequeathed her. At the same time I do appoint my trusty friend Zachary Green Executor of this my last will & testament also Guardian to my said daughter Natty Krin.
