I Jacob Arthur of the County of Currier and
State of North Carolina do make and ordain
This my last will and Testament in the follow-
ing form that is to say I Recommend my soul
unto god and my body to the earth I Give
and Bequeath in the following form -

I Give and Bequeath unto my daughter Elizabeth
Jann Arthur one two year old Heifer at my Decease
I Give and Bequeath unto my Sister Hecy Arthur
one year old heifer last spring she is unmark to be
delivered by my Executor at my Decease

I Give and Bequeath unto my Beloved Wife Nancy
Arthur after my Just debts is paid all of my prop-
erty in house and out of doors with my house and
Lands and all of my tenements during her widow-
hood to Dispose of as she thinks Proper and at
her decease to Return to my daughter Elizabeth Jann
Arthur for them and theirs heirs to have and to hold
in quiet possession This my last will and Testament
lastly I do make and ordain Geo. Gillikin to Be my
Executor as witness my hand and seal this the thirde
day of November in the year of our Lord one thousand
Eight hundred and twenty
