 sell a tract of Land lying in the County of Leman

 two Hundred and fifty Acres more or less, being a Part
 or Part of Land purchased by me from James
 Dick, by and bearing date the fourteenth day of
 October in the year of our Lord one Thousand Seven
 Hundred and ninety nine, and for me and in my

 requisite for conveying the Title of the said Land
 to the purchaser or purchasers thereof hereby giving
