Know all men by these presents that John Connally of Caswell County North Carolina and Charles Connally of the County of Effort one State of Georgia have nominated and appointed and do by these presents constitute create and appoint our Trusty and Wellbeloved friends George Connally of Nitoway County and Common Wealth of Virginia our True and Lawful Attorney for us, in our Name and for our use to ask demand sue for and recover all debts Legacies or Revenues due to us in the said State of Virginia, and on receiving the same full and ample receipts and discharges to give in our Name

And we hereby Grant to our said Attorney our whole Power ratifying and Confirming whatsoever he may lawfully do and do touching the Premises. In Witness whereof we have hereunto set our Hand and affixed our seals this first day of November in the XXnd year of our Independence Anno Domini 1797
