 Carolina my held and County bound into the Custody of the
 aforesaid County and that Paraguer in Office in the Sum of
 Two Hundred and six pounds Three which Payment well and
 truly to be made on said County and this County James
 Egerton and Generaly for the said County sealed with said Seal
 and Dated the Tenth Day of October A.D. 1787

The Condition of the above Obligation is Such that Whereas the
 above James Paraguer hath undertaken to build and
 maintain a Bridge above Mill Creek at a place called and known
 by the name of South fork of Mill Creek, the Condition hereof
 of the Obligation is Such that if the said James Paraguer
 shall quit and truly keep and maintain a good sufficient
 Capable Bridge at the aforesaid Place for Carriages and
 Carriages of every Denomination for and running the Space &
 Term of Seven Years from the 1st Day of May last past
 then the above Obligation to be Void Otherwise to remain in
 full Force & Effect
