To all People to whom these presents shall come I Gideon Patterson of Carroll County and Greeting Sheweth That the said Gideon Patterson for and Consideration of the Natural Love and Affection which I have unto my Beloved Nephew James Sanders of the said County and for Divers Other Good Causes & Consideration me hereunto Moving have given Granted and to these presents do give and Grant unto the said James Sanders all and Singular my Goods & Chattels following One Negro man Sampson One Negro Woman Moriah & also two feather beds with the furniture three plates and Dutch Cloves and six plates three Dishes and three Basons 1 dog 2 Sheeps two Cows and Yearlings Nine head of Sheep and two One Horse and Saddle & Bridle Plantation Utensils also all debts which are due to me whether on bond or Open Accounts I have hold and enjoy all and Singular the said Goods Chattels & Personal Estate wherever due unto the said James Sanders his Executors Administrators and Assigns to the only proper use and behoof of him the said James Sanders his Executors Administrators and Assigns forever and I the said Gideon Patterson all and Singular the aforesaid Goods and Chattels and Promises to the said James Sanders his Executors Administrators and Assigns against all persons whatsoever State and well warrant and forever Defend by these presents in Witness whereof I have hereunto set my hand and Seal this 12th day of January 1788.
