Son William Stuart son of James Stuart one young Man and Satisfy one Girl to my last beloved Elizabeth Stuart one Girl to my well beloved Rachel Stuart ^{one Girl} to my well beloved Daughter Agnes Stuart one Son, to my last beloved son James Stuart one young Man and Faly Shilling

I Appoint to my Son Agnes Stuart My Son and bequeath all the Rest of my personal Estate likewise my land her heirs to Anne the Children on, and After her Death to be sold and Equally Divided between my Five Children Viz^t William Stuart Elizabeth Stuart, Rachel Stuart Agnes Stuart James Stuart and Satisfy Constable Order and Appoint my loving wife Agnes Stuart and Cordie Ann and Elbert Moore my Executors to this my Last Will and Testament hereby Resolving and Making void all Other Wills or Wills by me Made and so Ratify and Confirm this Only to be my Last Will and Testament In Witness whereof I have hereunto set my hand and the day and year first above Written

Part line containing about One Hundred Acres Upon More, be sold by my Executors for the use and behoof of my Family Item it is my Will and Desire that all my Personal Estate and Household Furniture be Equally

Divided amongst my Girls Viz^t Betty Pally, Resiah, Abigail, Priscilla Robinson and also the Negro which Name will be sold on the same day they shall be able to add the Money Equally Divided amongst the girls before mentioned Item it is my Will that all Debts due to me after my

my Executors Debts are paid) Either by bond Upon due or any otherwise be made by my Executors and the Money be Equally Divided amongst my Daughters before mentioned. Item I constitute and appoint my wife Priscilla Robinson and Joseph Robert and to this my Last Will and Testament Revoking and annulling all Other Wills by me before made or to be made in any other Manner in my Name including the Sale here of In Witness whereof I have hereunto set my hand and the day and year first above Written this 31st day of May the thousand seven hundred and Eighty three
