

WILL OF ANNIE YODER.

In the Name of God: Amen.

I, Annie Yoder, of the County of Catawba, and State of North Carolina, being of sound mind and memory and knowing the uncertainty of this frail and transitory life, I therefore ordain, declare and publish this to be my last Will and Testament as follows: -

First: of all after my lawful debts have been paid, I give and bequeath all my personal property, consisting of one bay horse, one cow one wagon all my household and kitchen furniture all money and credits, all grains of any kind, all bedsteads and bedding, and every other article or property not mentioned, that I possess at my death, to my two daughters Catherine E. Yoder and Barbara J. Yoder, and after their death to Louetta Yoder, Catherine daughter.

LAST WILL OF N. CAMILA GILLELAND.

North Carolina. - Catawba County.

In the Name of God: Amen.

I, Camila Gilleland of the County of Catawba, and State of North Carolina, being weak in body, but of sound mind and memory and understanding, I praise be to God for the same, do make this my Last Will and Testament in manner and form following: I give and devise and bequeath unto my nephew Tate T. Leonard, all my interest in a certain tract of land lying on the north side of the Litton Creek and known as a part of the William Litton lands, and on which Logan Kale now lives, containing forty one acres, more or less, except two acres which I bequeath to Logan L. Kale, to be run off so as to include his dwelling house and other buildings.

2. I give, devise and bequeath unto my nephew, Tate T. Leonard all my interest in the home place known as the Thomas Gilleland lands, to have and to hold during his life time, at his death to be equally divided among his children, but if his present wife Eller Leonard, should outlive him (T. T. Leonard) I want her (Eller Leonard) to have her maintenance off of the place during her widowhood.

3. I give, devise and bequeath unto my nephew Tate T. Leonard all my personal property of whatever kind or nature and wheresoever the same may be found at my death.

And I do nominate, constitute and appoint my nephew Tate T. Leonard my Executor of this My Last Will and Testament, hereby revoking and making void all and every other will or Wills at any time heretofore made by me and do declare this my Last Will and Testament.
