

The last Will and Testament of Christina Bandy

Christina Bandy of the county of Catawba and state of North Carolina being of sound mind and memory but considering the uncertainty of any earthly existence do make and declare this my last will and Testament in manner and form following that is to say

First that my executor hereinafter named shall provide for my body a decent burial suitable to the wishes of my relations and friends and pay all funeral expenses together with my just debts howsoever and whosoever owing out of the moneys that may first come into his hands as a part or parcel of my estate.

Secondly, I give and bequeath to my daughter Angelina Ellenor Bandy one road wagon and gear also one cart, all one buggy and harness also my stock of hogs on hands also my stock of cattle on hands or may be on hands also all my stock of sheep or that may be on hands, also my mare and all her increase, also all my household and kitchen furniture all my farming utensils also one loom and all the implements belonging to it also one beam also one cupboard also one folding table also two common tables also one lot and tent at Balls creek campground and all its improvements also three chests also all my sitting chairs also five bedsteads and furniture also all my bees on hands or that may be on hands also one side saddle and Bridle also all of my wheat and corn on hand or that may be on hands also two wash pots also one kitchen cupboard.

My will and desire is that all the residue of my estate, if any, after taken out the debts and legacies above mentioned shall be sold and the debts owing to me collected and if there should be any surplus over and the payment of my debts and expenses and legacies that such surplus shall be paid over to my daughter Angelina Ellenor Bandy

and lastly - I do hereby constitute and appoint my trusty friend Thomas Wilkerson and my daughter Angelina Ellenor Bandy my lawful

executors to all intents and purposes to execute this my last will and testament according to the true intent and meaning of the same and every part and clause thereof hereby revoking and declaring utterly void all other wills and testaments by me heretofore made in a witness whereof I the said Christina Bandy do hereunto set my hand and seal the 15th day of June 1864 signed sealed published and declared by the said Christina Bandy to be her last will and Testament in the presence of us who at her request and in her presence do subscribe our names as witnesses thereto
