

Will of Elizabeth Fulbright

North Carolina, Catawba County.

I, Elizabeth Fulbright of the aforesaid County and State being of sound mind but considering the uncertainty of my earthly existence do make and declare this my last will and testament.

First

My executor, hereinafter named, shall give my body a decent burial and pay all funeral expenses, together with all my just debts, out of the first money which may come into his hands belonging to my estate.

Second

I give and devise to my trusty friend and cousin Sally Shook one half undivided interest in all my real estate.

Third

I give and devise to my brother Henry Fulbright during his natural life, and then to his daughter Eugene A. Fulbright one half undivided interest in all my real estate.

Fourth

I give and bequeath to my niece Eugene A. Fulbright one bed.

Fifth

I give and bequeath to my friend and cousin Sally Shook all the remainder of my personal property of all kinds whatsoever.

Sixth

I hereby constitute and appoint my friend M. J. Cochrane my lawful executor to all intents and purposes to execute this my last will and testament according to the true intent and meaning of the same, and every part and clause thereof hereby revoking and declaring utterly void all other wills and testaments by me heretofore made.

In witness whereof, I, the said Elizabeth Fulbright do hereunto set my hand and seal, this 18th day of January 1896.
