Candaces E. Carpenters heirs representing her share, F. P. Moser no more interest in my real estate shares his part of personals if any, Jane E. Rockett her share Leure Pope

Share, J. H. Moser share, C. A. Holler share R. L. Moser, Emma M. Sigmon J. E. Moser their shares, Minnie E. Hoke her share as already named and C. L. Moser his share allshare alike as named above. Lastly I appoint Jogn H. Moser my lawful executor to execute this my last will and testament, and pay all my debts according to law.
