In this case they to wait until favorable opportunity of realising - I appoint my wife and Thompson McCleary Joint Administrator and Ad-trix for the purpose of winding up investing &c, as they see fit: And I also bequeath out of my estate One Thousand (\$1000.) to each of my sisters and One Thousand to Hannah McCleary my wife's sister, these amount to be paid them on or before two years after administering. Thompson McCleary to be paid for his services as administrator a fair remuneration.
