Also I give with the above land to said Kennedy & in the said
 value one acre of the said Meadow to be laid off on the upper side
 of the my daughter Mary Ann & give her the Irish born slaves &
 purchase of Margaret Reder and as much of the said Reder land
 adjoining to the said Reder as will make her one hundred acres
 and one acre of the Meadow adjoining that will be to
 Kennedy, this land & value to be worth three thousand dollars
 I also allow her the value of one hundred dollars in debt of
 James Holt & other furniture & sum of it is now about my hands in
 my name in addition to that I allow my daughter to have
 valued by two impartial persons and what ever the value be
 valued my land of one hundred dollars I want them to pay her
 out of my estate in money to make her portion equal with the
 rest of my children

Long of Probate Court as my own share in any other not willing
 that my life and not wish to hold it I want my daughter to sell according
 to the law the money arising from such sale I want to be
 equally divided with my wife and all of my children each
 having alike.

Such Probate as my wife wish to return for her use and all the
 land I have will be for I want at her death as intimated by with
 any other person my daughter shall sell according to law allowing
 any of my land whom I appoint my daughter to sell at any date
 in the and amongst provided the sale is a fair & open sale & should
 either of my sons purchase any or either of the pieces of land I want
 the other one or two to sign and I desire deeds to be done
 becoming the purchase, and I beg request that Elias Vane &
 David Fisher my two sons execute this my last will & Testament
 & I beg make all former wills by me made & publish
 Penman this my last will & Testament which I have signed &
 sealed in the presence of Maxwell Wilson & his wife, Margaret in
 the presence of each other.

In the name of God Amen I Mary Ann Wife of Elias
 Blodgett of the County of Berkshire & State of New Hampshire being of perfect
 sound disposing mind & memory but considering the uncertainty of my
 earthly existence do make and publish this my last will & Testament
 in manner and form following that is to say
 First that my executor hereafter named pay all my just debts hereon
 and to whatsoever arising out of my estate that may come into his
 hands as a part or parcel of my estate

Then I give and devise to my daughter Mary Ann wife of Elias
 Blodgett all that property of mine which said Blodgett jointly
 owned or whatever part thereof shall remain or may remain at
 the time of my death and for which property I have a bill of sale
 in instrument of writing given said Blodgett bearing date the 13
 day of February AD 1832 to me the said Mary Ann Wife of Elias
 Blodgett and her personal representatives absolutely for ever
 Hereby My will and desire is that all my land shall be sold on a reason-
 able credit either in whole or part to any purchaser or in different
 tracts as I direct to different purchasers either at public or private

sale at the direction of my executor my further will and
 desire is that all the residue of my estate not otherwise disposed
 of shall be sold on a reasonable credit and the debt owing to
 me be collected and the surplus after paying my debts funeral
 expenses & that such surplus shall be equally divided and
 paid over to my daughter Mary Ann wife of Elias Blodgett
 and all her children (if any) born that she now has or what ever child
 she may have born at the time of my death in equal por-
 tion to them in their personal representations absolutely for ever
 And lastly I do hereby constitute and appoint my trust friend
 Joshua Wilson my true and lawful executor to execute this my
 last will and Testament according to the true intent and meaning
 of the same and any part and clause thereof being nothing all
 former wills and Testaments by me heretofore made in writing
 Whence I the said Mary Ann Wife have hereunto set my hand
 and affixed my seal this 10 day of January AD 1844

Signed sealed published and delivered by the said Mary
 Ann Wife her last will and Testament this in her presence
 and at her request have subscribed our names as witnesses
