

I, Jacob Lutz, of the County of Catawba and State of North Carolina, being of sound mind & memory do make, publish and declare the following to be my last will and Testament in manner and form following to wit:

Item First. I desire my executors hereinafter named to pay and discharge all my just debts.

Item Second. I devise unto my wife Mary Ann the following land, including my dwelling house & other buildings, being the east part of my home plantation the line to commence near the school house and to run along the road nearly south East a direct line to Mason Sigmund's corner (Ston Corner) then with Sigmund's line East and along Peeps and Fries lines to the beginning corner near the school house to include the above boundary being about 116 acres more or less, during her natural life, and at her death to be sold by my executors and divided equally among my children per stirps -

Item Third. I will and bequeath to my wife Mary Ann, viz. Two horses and one mule her choice, four (4) cows her choice, four (4) head of young cattle her choice, all the hogs on hand and ten (10) head of sheep her choice, all the house hold and kitchen furniture of every description, one buggy and harness, one cart, one two wheel wagon and necessary gear, all the farming implements including all the plowing, one side saddle & all the other saddles on hand, also my molasses mill and fruit evaporator fueler organ. Also all the Wash Pots & tubs on hand, also two hundred bushels Corn seventy five (75) bushels of wheat on hand or out of the growing on 1880 one half interest in wheat drill, five hundred lbs. of bacon, all the land on hand. Also all the roughness on hand

including all the oats on hand or growing. To have and to hold during her natural life, and at her death to be sold and divided as directed in item second of this will.

Item Fourth

It is my will and desire that all my property both personal and real estate, including notes not herein willed shall at my death be sold by my executors and the proceeds of, together with the money on hand, be equally divided among all my children per stirps, after paying the bequest in item five.

Item Five -

It is my will and desire that my children by my present wife shall upon arriving at twentyone years of age have one hundred Dollars each to make them equal with my other children to be paid to them in addition to the pro rata division mentioned in item second, third, and fourth.

Lastly I hereby constitute and appoint my son Sidney Lutz, and my son in law John Warlick my executors to execute this my last will and testament, revoking all former will, to my made and declaring them utterly void.
