

July Session 1863

174 I now all now by these presents that I Philip Sizman of the County of Calhoun & State of North Carolina being last butto out of sound mind & memory do make this this my last will & Testament as to my No. 1 wife and all the property real and personal of which I may die before and provided I Devise Bequeath and dispose of in manner following to wit.

Item 1st My will is that all my just debts & funeral expenses be paid by my executors hereafter named to be paid out of my estate as soon after my decease as shall be by the executors convenient I give & bequeath to my beloved wife all my negroes Miles Friona James &ingo Barbara & Jane my will is that Friona and Jane shall attend to my wife Elizabeth Sizman as house or body & servants the above named Miles to be sold if necessary and another bought with the proceeds

Item 2nd I will at my Stock provisions grain farming tools House hold & Table Furniture Wagons Carriages Blacksmith tools Cots Stell & Bassinets and everything to remain on the Plantation at my decease also the plantation I now live upon and all the proceeds thereof during her life or so long as she remains the widow Elizabeth Sizman and after her decease my late estate to be and equally divided among my four children Benjamin Joshua Marcus and Warrens

And lastly I do nominate and appoint my said sons Benjamin & Joshua to be my executors in this my Will and Testament

In testimony whereof I the said Philip Sizman have to this my last will and Testament affixed my seal this 26 July 1863

177 In the Name of God Amen. I Mahala Sherrill of the County of Calhoun and State of North Carolina being of sound mind & memory and Considering the uncertainty of this frail & transitory life do therefore make Ordain publish & declare this to be my last Will & Testament that is to say First after all my lawful debts are paid & discharged the residue of my Estate real and personal I give and bequeath and dispose of as follows to wit

Item first I give and bequeath unto Logan Wilson as trustee for the use of my beloved wife Elizabeth M. Wilson and Negro man named Jack one Negro man named Dick also one negro girl named Jane to her use during her natural life and after her decease to the use of the lawful begotten heirs of her body each child to share & have alike Item 2nd I also give & bequeath unto Logan Wilson as trustee for the use of Elizabeth M. Wilson one thousand dollars

Item 3rd I give and bequeath unto Logan Wilson as trustee for the use of Elizabeth M. Wilson her two daughters Florida and Alice Wilson one hundred & five dollars to each daughter

Item 4th I give and bequeath unto Logan Wilson as trustee for the use of Elizabeth M. Wilson one bed & furniture also an half of my house hall & kitchen furniture Item 5th I give & bequeath unto Logan Wilson as trustee for the use of Elizabeth M. Wilson All my land lying above what is called The High Shoals and Falls Creek the line to run North & South from the high shoals to her use during her natural life and after her death to the lawful begotten heirs of her body

Item 6th I give and bequeath unto Logan Wilson as trustee for the use of Elizabeth M. Wilson five acres in the Western N.C.R Road to her use during her life after her decease to the lawful begotten heirs of her body

Item 7th I give & bequeath unto Middleton & Hobbs as trustee for the use of Belga Austin James one negro man named Allen and one girl named Catharine one negro girl named Mary Jane one negro girl named little Katherine during her natural life & after her decease to the use of the lawful begotten heirs of her body each child share & have alike

Item 8th I give and bequeath unto Middleton & Hobbs as trustee for the use of Belga Austin James All my Lands lying below the line running from the high shoals and Falls Creek and which my house stands to her use during her natural life after her decease to the use of the lawful begotten heirs of her body each one to share & have alike

Item 9th I give and bequeath unto Mahala Eleonora James one Bed and furniture

Item 10th I give & bequeath unto Middleton & Hobbs as trustee for the use of Belga Austin James The rest of my bed not disposed of already am half of my house hall & kitchen furniture

October Session 1865

Item 11th I give & bequeath unto Sarah Wilson & Middleton & Wells one hundred & twenty dollars for the use of Elizabeth M Wilson & Bfz. I give & leave my Hand Brushing Machine which are one half of it. In case of her death of Bfz & James and all her children all the property left to her revert to my nephew - Middleton & Wells.

Item 12th My will & desire is that Sarah Wilson and Middleton & Wells who stay for the use of Elizabeth M Wilson & Bfz. I give & leave so that my wife Maria is to have & keep one half of living life and, Maria to have her support from Elizabeth M Wilson & Bfz. I give & leave with either of them

Item 13th My will and desire is that, Bfz. have her support from Elizabeth M Wilson & Bfz. I give & leave her advice to live with either of them

Item 14th I give and bequeath unto my nephew, Middleton & Wells Elizabeth Pasture Seven hundred Dollars

Item 15th I give & bequeath unto my Nephew Middleton & Wells one hundred Dollars

Item 16th I give & bequeath unto my Niece Remannah Brown one hundred Dollars

Item 17th My will and desire is that all the rest of my property not herein disposed of be sold and all my debts paid and the balance if the money arising after my debts are paid to be equally divided between Elizabeth M Wilson & Bfz. I give in trust as aforesaid of make and constitute and appoint my friend A. Mc Powell creator of this my last will & testament freely & lawfully dividing all former wills by me made in writing whereof I have brought before him my man and affixed my seal the nineteenth day of June in the year of our Lord one thousand eight hundred & sixty three

October Session 1865

178 In the name of God, Amen. I William Linton of the County of Catawba & State of North Carolina being of perfect sound mind & Memory blessed by God do this 24th day of September 1865 Make, Publish & Ordain this my last Will & Testament in the form & manner following viz:

First I will & bequeath unto my beloved wife Ediza the use of all my land during her natural. I also give unto her two mowes named Sam & Syria also one waggon & Buggy and one carriage all of my farmings tools of every description all of my wheat and oats and all of my corn that is growing in the fields all of my house hold & Kitchen furniture all of my Cabbard all of my cattle Hogs & Sheep I will my fifty to be sold to pay my debts either by private or public sale and if she does not bring money enough to pay my debts my Executor is directed to sell enough other property such as my wife can best spare to pay the balance I give & bequeath unto each and every one of my girls their beds & furniture belonging to them I give unto Ediza a walnut tree, I will that my wife shall raise my son Alexander a bole by the time that he is twenty one years old I give my son Alexander one hundred & fifty acres of Land at my wifes death to include my house and other buildings and a part of the Matthew Edwards place so as to get timber & and the balance to be divided amongst all my Daughters after my wifes death. I hereby constitute and appoint my worth friend Mrs Sharpe my executor of this my last will & testament Severe under my hand and seal in presence of
