In the Name of God Amen, I Michael Link of the state
of North Carolina & County of Catawba I make my will
and Testament in manner & form following:
First I give and bequeath unto my wife Sarah my
plantation during her natural life ~~on~~ widowhood
and also all my house hold and kitchen furniture
my Canpall Wagon my clock & horses hogs sheep
and cattle and all my property I own at my
death and her money; she may dispose of as she
pleases all the property; she may sell or dispose of
as she please; and the plantation after her death
I will that my oldest daughter Catharine to have it
if she will pay my daughter Rebecca half the value
tion of the land: Ephraim Whisenhunt and Darius
Seitz choose four men to value the plantation and
if Ephraim Whisenhunt think the four men value
the land too high I will they set it up to highest
bids; I bequeath to my two daughters Catharine
Whisenhunt and Rebecca Seitz all my money on hand
and outstanding to be equally divided between them two
I appoint Ephraim Whisenhunt and Darius Seitz my
executors of this my Will and Testament in witness
whereof I have hereunto set my hand and seal
this the 28th day of September 1860, Signed sealed
and published & delivered by the above named
Michael Link to be his last will and Testament
in the presence of us.
