Up the name of God, Amen, I Phillip Barker son of the County of Catawba and State of North Carolina being of sound & perfect mind & memory doth by this my last day of October in the year of our Lord one thousand eight hundred and fifty two make and publish this my last Will & Testament in manner and form as follows that is to say Item First I give and bequeath my soul to God & my body to be buried decently by my heirs after natural decease as to my worldly goods it is my will that funeral expenses be first paid out of this my estate and the remainder of my estate to be distributed as follows Item Second I give and bequeath to my dear eldest daughter Mary Susannah & Polly a tract of land lying in the town of Liles Chark containing Martin Seehaus George Taylors & others containing 230 acres more or less Item 3 I also give & bequeath unto my son Philip the same plantation that is that owns Joseph Hunsucker Dillingers & Jacob Seehaus containing by estimation 160 acres or less also one house & one Road wagon & one tanson built 2 years ago Item 4 I also give & bequeath unto my two sons & four daughters my dear tract of land namely Henry Martin Sally Buttman Hurst & Schenner to be equally to be divided among them the tract to contain 370 acres more or less I also give my son Henry one house after my death and the same that he has got & my son Martin one house & a calf that is about 6 months old one wagon for plantation Item 5 I also give to my three sons said Henry Martin & Schenner my blacksmith tools and ten acres of land where the saw mill is to include the pond and mill and shale to run as the wish to have it Item 6 I also give & bequeath to my son Philip another small tract of woodland containing Martin Seehaus and Mary & Dorothy Mass containing forty acres more or less Item 7 I also give and bequeath unto my four youngest daughters one hat each & one whale & cards one Cat & Calf each Harriet & Salina one saddle each also each of my four daughters to have five dollars to furnish them with clothes as they wish Item 8 it is my will that the remainder of my property after paying my debts to be equally divided among my lawful heirs that is not yet settled to be done by my executors at public sale & the money to be divided Item 9 it is also my will that my said Phillip Barker be my executor of this my last Will & Testament and as hereby entirely disallowe revoke & disanull all and every other former Wills & Testaments so as bequeath's executors by me in any way before this term named Phillip & his executors ratifying & confirming this last no other to be my last will & testament in writing I have set my hand & affixed my seal the day and year first above written Sealed, sealed, published, pronounced by the said Phillip Barker his last will & testament in presence of us the subscribers witness

137 I Joshua Wilson of the County of Catawba and State of North Carolina being of sound mind & memory but Considering the uncertainty of my earthly existence, do make and declare this my last Will & Testament in manner & form following that is to say First that my executors (herein after named) shall provide for my body a decent burial suitable to the worth of my relations & friends and pay all funeral expenses, together with my just debts, however to whomsoever rising out of the money that may come into his hands as a part or parcel of my estate Item 2 I give and bequeath to my son-in-law Rufus England and his wife Miss Sophia England (who is my daughter) all my lands or real estate that I now own either in this County or elsewhere that all the interest I have in any lands either by myself, heirs, executors or otherwise to have and to hold said lands in equal proportion where to share alike to them & their Heirs in fee simple forever Item 3 I also give and bequeath to my said son-in-law and daughter Rufus England & Miss Sophia England my negro slave named Prince and all other Personal Property that I now know or may know at the time of my death and all Chattels that may be in hands or falls owing to me at the time of my death I give to them in equal proportion share & share alike to them & their personal representatives, moreover Item 4 I do hereby constitute and appoint my son-in-law Rufus England my lawful Executor to all intents & purposes to execute this my last Will & Testament according to the true intent and meaning of the same hereby revoking and disowning utterly void all other Wills and Testaments by me hitherto made In witness whereof I the said Joshua Wilson do hereunto set my hand and seal this 17th day of September 1863
