I, J. A. Sherrill, being of sound mind, and memory, do make this my last will and testament, in the manner and form following:

That is to say first, my executor, hereinafter named shall provide for my body a decent burial, according to my position and standing in life.

The same also for my wife Ida J. Sherrill, and the expenses to be paid out of my estate.

2nd. I will that any and all just claims, if any therebe, at my death, be settled by my executor, and then, that my entire Estae, real and personal go to my wife Ida J. 4th. My will is, that in the event, and in the order of Providence, my present, wife Ida J. Sherrill, should bear a child or children to me, then the above is and stands revoked to the extent, that my wife Ida J. Sherrill shall have the use of my estate during her natural life as above stated, and then the same goes to my child or children, as is stated in this proviso. I hereby appoint my wife Ida J. Sherrill my legal executrix, with my friend P. a. Thompson if living, to assist in the execution of my last will and test ment, and if he be not alive, for the proper authorities to appoint some other comparent member of the M. E. Church South, as the
