In the name of God Amen I Angulus Henderson
of Chatham County and State of North Carolina being of
sound and perfect mind and memory. Moved to testify this
six day of September in the year of our Lord one thousand
eight hundred and four make and publish my last will
and Testament in manner following. That is to say. First
I gave and bequeath Francis Clark one Negro Girl Hannah
and if the said Negro Girl Hannah live to have a child
it is to be for Mary Henderson daughter to the said Francis
Clark. And also I gave to my son Theophilus Henderson
the Negro Girl. Also I gave to my son John Henderson
the manner plantation where I now live on the corner of
the land beginning at the mouth of the School House
Spring Branch, running up the said Branch to the
back line. Thence West to John Potts Spring Branch.
thence across the said Branch to Brooks Creek thence
down the said Creek to the first station. also one Negro
Wench Luce and Child Humphreys. Also I give unto
Abigail Henderson all of my land west of John Potts

Spring Branch during his natural life or widowhood then
to her heirs. And I give unto my son Lewis Henderson the
Land where he now lives on all of my Land on the south
side of Bruckers Creek, also one Negro Fellow George Saborgoon
with my son Isaac Henderson. One Negro Wench Dick and a
Child. And I also give unto my son Egbert one Negro boy
called Althe. I also give unto my son daughter Rachel
Henderson, one Negro Girl Cissy and one Old Furniture
I also give unto Elizabeth Henderson one Negro Servant
by the name of Betty. I also give unto Frances Clark one
Negro Boy named Jerry to her & her heirs forever. I also
leave unto Abby Henderson one Negro Boy being during
his life widowhood, and then I gave the same Negro Boy
to her heirs equally to be divided amongst her children. I also
gave unto the wife of Lewis Henderson's children except Rachel
Stevins, Stollings, equally to be divided amongst them and also
all of the rest of my property to be sold and equally divided
amongst my heirs except my son and Black Smith's
Duties to be kept on the plantation of the year of all my
heirs and plantations. Except one third of my estate to
Isaac Henderson daughter Sally and Henry, making
and my worthy friends John Henderson my son
George Barnard and John Mackinay Sen. Executors of
this my last will and testament. And my hand I seal
the day & year above written. I give also give unto
Elizabeth Nickerson twenty Dollars out of the money my
deceased by the same Negro Lewis Henderson the testator
in his last will and testament in the presence of us

who were present at the time of signing sealing thereof

In the name of God Amen I Robert Parker
of the County of Chatham and State of North Carolina being
very sick and weak but in perfect mind and memory
Wishes to give unto God, calling unto mind the mortality
of my body and knowing that it is appointed for all men
once to die, do make and ordain this my last will and
testament, that is to say, principally and first of all
I give and recommend my soul unto the hands of almighty
God that gave it, and my body I recommend to the
earth to be buried in decent Christian burial at the
direction of any executors, putting a scattering but at the
general direction I shall receive the same again by the
mighty power of God; And as touching such worldly
estate wherewith it has pleased God to bless me in
this life, I give, devise and dispose of in the following
manner and form

First I give to my beloved wife Sarah Parker the
plantation which I now live on and one Negro man
by the name of Lewis and one Negro woman by the
name of Cato, also one Negro Girl by the name of
Sissy, and one by the name of Dick, and also by the
name of Frances two cows & Cato, her choice out of
my stock of Cattle, and six head of Sheep, her choice
out of my stock of Sheep likewise all my household
