ner & form as follows To wit

Item 1st That all just debts be paid

the residue of my property both real & person-
al during her natural life with the objection
to her selling off any Timbers or saw logs
off of the land so loaned to her

Item 3rd Then after the death of my wife Nancy
as aforesaid I give & bequeath to my niece Martha
Johnson & her bodily heirs all of my Estate above
mentioned to her & her bodily heirs forever

4th And Lastly I do hereby nominate consti-
tute & appoint my trusty friend Lemsey John-
son my Executor to this my last will & testa-
ment revoking all others by me made and
acknowledge this & this only to be my last will
& Testament in manner & form as above stated

they have full power to make sale of it or of
any part of it either publicly or privately at
their discretion

A Turner continue to act as agent in collect-
ing the debts for my paper & that he receive
the same commissions therefor that I now
pay him and lastly I do nominate and
constitute & appoint my very worthy & much
esteemed friends Doct Leno A Hawks & Nathan
A Stedman the Executors of this my last will
and Testament hereby revoking and declaring
utterly null any will or wills by me at
any time heretofore made
