- 1st Item I Give and bequeath unto my son William League my Negro Man Peter to him and his heirs forever by his giving up a Note he holds against me
- 2nd Item I Give and devise unto my son Solomon League The Plantation whereon I now live including all my Land estate to him and his heirs forever
- 3rd Item I Give and bequeath unto my son in Law William Carter my Negro Woman Lacey and her son Squares by the said Carter paying to John Record and Thomas Rogers each eighty dollars at or before twelve Months after this takes place effect
- 4th Item I Give and bequeath unto my son James League Children to W^{ts}. Rebecca Andrew and James ^{two} hundred dollars to be equally between them
- 5th Item I give and bequeath unto my Daughter Sally Petty one dollar in Addition to what I have already given her as her portion of my estate
- 6th Item I give and bequeath unto my daughter Polly Stokes Children say the Heirs of her body eighty dollars to be to be paid over at the discretion of my Executors
- 7th Item I Give and bequeath unto my niece Ruth Pope one Red Ox Counter pin and Sheet
- 8th Item My will is that all the balance of my property consisting of every thing of which I may be possessed die in possession and not before devised or bequeathed are to be sold and the Money arising from such sale be equally divided between my following Children namely John William Solomon Elizabeth

Be it remembered that I John Atkinson of North Carolina
Chatham County considering the uncertainty of this mortal life
and being of sound and perfect Mind Memory and Reason
do make and Ordain this my last will and Testament in manner
and form following Viz first my will is that all my just
debts together with my funeral charges be paid out of my
estate - I Give and bequeath to my wife Mary Atkinson one
bed and furniture One Blank Wheel and one Saddle for her
use and at her disposal. I also give to my wife one horse
cette and bundle of her own choosing ^{my stock} out of horses One cow
one case of drawers four sheep two plows and the necessary
grazing for them for her use as long as she remain my widow
I further give to my wife one year provisions for herself and
family I also give to my said wife my dwelling House
and the plantation on which I now live for her use during
her Natural life or so long as she shall live

I give and bequeath to my four sons James Thomas Hugh
and Robert my Tract of land in Orange County Indiana
the description and boundaries of which are ^{expressed} in a
Deed of Conveyance from Hugh Woods to myself to be equally
divided among them my above named sons to them and their
heirs forever and assigns forever
