living Brothers and Sisters that is to say John Quakerbush

 my debts and funeral Charges and if there should be
 any left after paying my debts to be equally di-
 vided between Sidney Thomas and Eliza Pierce I
 hereby appoint Thomas McCannell and Eliza Pierce
 my executor of this my last will and testament
 hereby revoking all former wills by me made In
 Witness whereof I have hereunto set my hand and seal
 the fifth day of May One thousand eight hundred
 and thirty -
