and Jack and a colt Item I lend to My beloved wife
My house and a garden and Cotton patch Item I have
given My daughter Ann Headen as much of My estate
as I allotted for her also I have given My daughter
Phoebe Brooks as much of My estate as I allotted for
her and also I have given My Daughter Mary Brantly
as much of My estate as I allotted for her also I have
given My daughter Ruth Brooks as much of My
estate as I allotted for her also I have given My son
Jerrill Brooks as much of My estate as I allotted
for him I have given My daughter Elizabeth Hunter
as much of My estate I allotted for her also I have
given My daughter Sally Rogers as much of My estate
as I allotted for her also I have given My daughter
Milly Lechon as much of My estate as allotted for
for her Item I give to grand son Thomas Hanford
Headen the son of Phoebe one Negro girl Name Amy
Item I give to My son Joseph John Brooks all the
remaining part of my Land and Mill and also
all my hogs and sheep and one horse Name
Wacks and also one Negro man Name Francis

And one bed and furniture and one big Pot
I spirit my beloved wife and my son Isaac John
Brooks and Georg M. Math My executor of this my
last will and testament disannulling all other wills
or wills and this to be my last will and Testament
the 5 of March 1815

make constitute and appoint this my codicil
to the within will and Testament which will and
testament bear date the fifth day of March 1815
and I do hereby ratify and confirm each and every
part of said will except as is herein excepted to be my
last will and testament hereby revoking and disannulling
any other will or wills which I may have made before
or since the date of said will altering the said
will only in this that whereas in the said I have
given and bequeathed to my grand son Thomas
Stanford Needen the Negro girl named Amy Now
my will and desire is that his Mother Phoebe Brazier
shall have the use of said Negro girl and her in-
crease during her Natural life and then that
my said grand son Thomas Stanford Needen
shall have the said girl and her increase
in testimony whereof I have hereunto set my
hand and seal this 23 March 1816
