relying Hand & Memory thanks be to God for this Mercies
do make Ordain and publish this my last will and Testament
in manner following Viz First I recommend my Soul to
God who guards it that my body be decently interred
Secondly that all my Just debts be paid Thirdly I give
and bequeath to my beloved wife Sally Garner a Negro wo-
man named Fanny I leave to my beloved wife all
the rest of my Negroes Say Noda Daniel Tally Eda
Deey Wany Fuchid and all their increase with the
share of my land and all the rest of my property du-
ring his life and on widowhood And that my Children
should be educated in the profits of my property to each
share of all charge to themselves Fourthly at the death on
marriage of my beloved wife that my lands be equally
divided Amongst my three youngest Sons Gilead Gideon
and Samuel And that all my other property including the Negroes
together with Hannahs increase be equally divided Among
my present & future Children Say Gilead Gideon & Samuel of
my ~~son~~ Sons and of my daughters Jenny Emily & Elizabeth
Fifthly that all my other Children Gilead Gideon Amos
Isaac Noda and Polly Garner should have that prop-
erty I have before given them as their share of my estate
Sixthly I do hereby make and Ordain my beloved Son Gilead
Garner and my son in Law William Garner executor to this
my last will and Testament In witness whereof I have here-
unto set my hand & Seal this 5 day of September AD 1829

Be it remembered that I Solomon Dixon of Chatham County
and State of North Carolina being sick in Body but of
perfect sound Mind & Memory Calling to mind the frailty
of the Body and knowing that it is appointed for all men
once to die do make and Ordain this my last will and
Testament in manner and form following First I Order
that all my Just debts together with my funeral charges
be paid Out of my estate the remainder of which I will
and bequeath in the following manner First to my beloved
wife Sarah Dixon I give and bequeath a piece of land
lying on the South Side of Cam Creek adjoining Peter
Stout David Stout and others for her use I also give and
bequeath unto my beloved wife the North Side of the plan-
tation wherein I have lived Beginning at the South Side
fork thereof running north with my land & State it shall be
Solomon's heirs line together with the Buildings thereon for
her use State my daughter Hannah shall arrive to the age
of twenty ~~seven~~ ^{seven} years - Secondly I give and bequeath unto
my daughter Hannah all the plantation wherein I have
lived adjoining John Stuart Solomon Stuart J. P. Dixon
and others with all the appurtenances thereunto belonging
I also give and bequeath unto my daughter Hannah
all Bonds and Notes belonging to my estate Thirdly I
give and bequeath all my Stock of whatever Nature she
be unto my beloved wife for her use State my daughter
Hannah shall arrive to the age of twenty one years and
then the same to be my daughter Hannah's
Fourthly I give and bequeath my Dutch Clock Watch
and Naggon to my beloved wife for her use State my

daughter Hannah shall arrive to the age of twenty
One year Finally I give and bequeath to my beloved
wife All the property that I possess with her for her.
And let her dispose

Finally I give and bequeath to my beloved wife All
My plate and other ornaments of husbandry to
gather with all my house hold and kitchen far
niture of whatsoever nature it be for her and that my
daughter Hannah shall arrive to the age of twenty
One year And then the same to be my daughter Han-
nahs - Finally I give and bequeath unto my beloved
wife All my Grain & every description together with
All my other possessions for her use & rightly my will
is that my daughter Hannah shall have a liberal
School education And the expenses of which to be defray-
ed out of her own legacy Finally in Case my
daughter Hannah shall die under age or without issue
then in that Case my will is that All my real estate
be equally divided Amongst my Brothers and
Sister Sons And All my personal estate to be equally
divided Amongst my Brothers and Sister daughters
And lastly I Nominate constitute and appoint
My Trusty Friends Benjamin Dixon and Elisha Dixon
whole and sole executors of this my last will
and Testament in witness whereof I have
signed All my hand and seal the thirtieth
